Subject: **PROCEDURE FOR IMPORT OF ONE NON-PROHIBITED BORE (NPB) WEAPON BY THE ARMED FORCE OFFICERS, GAZETTED GOVERNMENT OFFICERS AND PARLIAMENTARIANS**

In partial modification of this Ministry's Notification of even number dated 24th May, 2017, Ministry of Commerce hereby re-notifies the amended Procedure for "Import of one Non-Prohibited Bore (NPB)" weapon for Armed Force Officers.

ARMED FORCES OFFICERS:

ELIGIBILITY:

The applicant must be serving Army, Navy, Air Force Officer or para-military force.

PROCEDURE FOR FRESH APPLICATION:

- i. Duly filled application form (Annex-A).
- ii. Endorsement letter from the Commanding Officer of the concerned unit of the applicant.
- iii. Endorsement of the Tri Service Headquarters (whose specimen signatures have been received in this Ministry) for respective Service, confirming the service status of the officer.
- iv. Army Regulations (2000) Section 475 to 486 will apply mutatis-mutandis and declaration to that effect shall be made by the recommending officer as per prescribed format in Annex-B.
- v. Attested copy of valid CNIC of applicant.
- vi. Affidavit/undertaking by applicant on stamp paper duly attested by the notary public along with two witnesses declaring that he/she neither applied nor imported one NPB weapon through Ministry of Commerce before (Annex-C).
- vii. P.A. Number.
