  - Be more than 3 year practical experience in IPR field
  - Be a graduate of university or equivalent
  - Be between the age of 25-45 years
  - Have competent command over English both in written and spoken
  - Be in good health both physically and mentally to participate in the program in Japan
  - Not be serving in the military.
