- The team lead should be a senior official of at least Deputy Secretary/ Director Level or above.
- The team has to identify an economic related challenge in his/her home country to work on during the programme.
- The team project has to be supported and endorsed by senior management of nominating organization.
- At the end of the Program, team will present a feasible action plan to the issues identified.


**Objective**

- The aim is to expand participants understanding of economic strategies, as well as to provide a platform for exchange of perspectives on economic-related issues in Asia. Singapore's approach and experience in managing the economy will also be shared.
- By end of Programme, Participants will be able to
  - Exchange ideas or share knowledge on global trends impacting Asia and Singapore.
  - Apply the knowledge of economics in public policy, such as industrial and competition policies.
  - Discuss key challenges in resources management and manpower development in an age of disruption.
  - Extend your network of peer support to further cross-border collaborations in Asia.
- Civil Service College and Temasek Foundation international will contact all teams to follow-up on and review their progress within 6 to 9 months after the TFLED programme ends in Singapore. They may visit selected teams to review the impact of TFLED in participants' organization.
