- Be in good health, both physically and mentally
- Have a good command of both spoken and written English in order to take classes conducted entirely in English and be able to write academic reports and thesis in English
- Not be a person who has withdrawn from KOICA’s scholarship program.  
\* Person belonging to the institution in which candidates submitted false documents and returned to his / her country arbitrarily in the middle of SP program cannot apply.
- Have not participated in KOICA’s scholarship program or any of the Korean Government’s Scholarship Program earlier (Master’s degree program)


**Objective:**
