

- Be personnel in charge of regional industrial development and promotion
- Have More than 3-years experiences in the relevant field
- Be a graduate of university or equivalent
- Be Between the age of 25 and 50 years
- Have a competent command of spoken and written English: as the participants are required to make presentations, have discussions and write reports in English.
- Must be in good health, both physically and mentally, to participate in the program in Japan. Pregnant applicants are not recommended to apply due to the potential risk of health.
