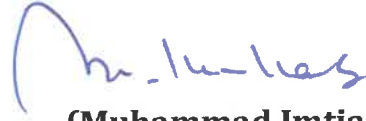

- Not be a person who has withdrawn from KOICA's scholarship program earlier.
- Have not participated in any of the Korean Government's Scholarship Program before.

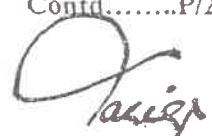

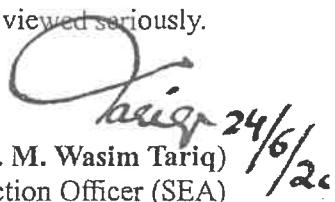
