MESSAGE FROM THE SECRETARY

Pakistan has dynamic, vigorous and export oriented textile industry that has an overwhelming impact on economy. Textile being largest industrial sector generates country's highest export earnings of about 56%; providing bulk of employment (40%) to largely underutilized workforce, and contributes 8.5% to GDP.

It may be interesting to mention here that Pakistan's textile sector has unique characteristics as on the one side our country produces about 9.9 million bales of cotton per year which make us the 4th largest producer of cotton in the world while on the other side our cotton needs to be upgraded to world best level and its quality needs to be improved. Our spinning sector is fairly large to utilize all the available cotton in the country. We earn only US\$ 13.33 billion from our production of 9.9 million bales despite the fact that we have a complete textile value chain. Although Pakistan is one of the top four cotton producing countries but still we are far behind the regional competitors in the area of value addition and consequential exports.

Main reasons obstructing growth of value added products are non availability of quality cotton which starts from not using good quality seed by the farmers, use of poor quality pesticides/inputs and poor farming techniques. Our cotton pickers are not properly trained. In nutshell there is a lot of room for improvement and value addition from ginning to garment production. There is tremendous scope to explore true potential of value addition so it can rightly be said that all these challenges are also providing opportunities. Our textile/ garment exports can reasonably be increased provided we could remove these inefficiencies through carefully selected government interventions.

The main objective of the Textile Division, Ministry of Commerce & Textile is to act as a credible, effective, efficient and dynamic organization for creating an enabling environment for sustainable growth of entire textile sector in the country and to augment value addition at each step of value chain of textile sector. The aim being to double the textile related exports in next five years by formulating strategies and programs to enable the textile sector to avail maximum benefits of the GSP+ status granted by the European Union. Moreover, to make the textile sector globally competitive, the Ministry has envisaged sharing policy guidelines with all stakeholders of textile value chain to take initiatives in order to improve their output and quality.

It is hoped that the readers will find the Year Book useful and informative.

OVERVIEW

Ministry of Textile Industry was created on 2nd September, 2004 with assigned responsibilities to formulate strategies and programs to facilitate the textile sector for attaining sustainable growth.

Pakistan has dynamic, vigorous and export oriented textile industry that has an overwhelming impact on economy. Textile being largest industrial sector generates the country's highest export earnings of about 58%; providing the bulk of employment (39%) to largely underutilized workforce, and contributes 8.5% to GDP.

Grant of GSP+ status by European Union demands a new focus for textile industry to international countries particularly on human and labor rights to which in turn would earn more foreign exchange for the country.

Textile Division is currently in the process of implementing and finalizing various initiatives like Research & Development, technological up-gradation and human resource development innovations in diverse products, maintaining standards, ensuring quality and to produce contamination free cotton to bridge the country's yawning trade-gap.

Pakistan textile industry is facing tough competition from the regional competitors. Due to a number of factors, the cost of doing business in Pakistan is high as compared to our competitors.

But on the other hand there exits immense potential for growth and development of textile industry. The grant of GSP+ status by the European Union and anticipated shifting of Chinese Textile Industry in neighboring countries bring many promises for the textile sector of the country, if we are prepared to harness these opportunities.

It is a pity that Pakistan earns data should be same as previous from our production of bales and despite the fact that we have a complete textile value chain, while Bangladesh is earning about US\$ 25 billion from its textile related exports despite the fact that it produces not a single bale of cotton. The reason of this situation is our negligence towards garment production/fashion industry.

To boost the garment production in the country, a number of projects like Lahore, Faisalabad & Karachi garment cities and Pakistan Textile City, Karachi were planned to augment the value added finished textile products in the country. It is a matter of satisfaction that Faisalabad and Lahore Garment Cities have been functionalized and initial results are very encouraging. Keeping in view the success of these Garment cities, plans are on the anvil to further expand these cities.

Unfortunately, the Karachi Garment City Company Project could not be started as yet owing to cancellation of the lease of land of KGCC by Land Utilization Department of Government of Sindh on the orders of Supreme Court of Pakistan. The Supreme Court of Pakistan has now declared that the earlier orders of Supreme Court were not meant for leasing of land for the Government departments and efforts are under way to get the title of land of KGCC from Sindh Government.

In line with the world market situation, the Ministry is striving hard to induce a new culture which would expedite the process of improvement in all the segments of textile sector and will be synergistic for industry to boost its share in global trade.

INTRODUCTION OF TEXTILE DIVISION

PROPERTY STATE

Ministry of Textile Industry was established in 2004 which is focusing on formulation of long-term policies to boost the textile sector for increasing productivity, diversification and to enhance the textiles exports through penetrating the international market by exploring new cliental and grabbing its maximum share with ultimate objective of country's progress and development.

Functions

In terms of Rule 3(3) of the Rules of Business 1973, the Government has allocated the following business to this Ministry namely:

- 1. Formulation of Industrial Textile Policy;
- 2. Coordination / liaison with federal agencies/institutions, provincial governments and local governments for facilitation and promotion of the textile sector;

- 5. Textile related statistics, surveys, commercial intelligence, analysis and dissemination of information and reports on international demand patterns, market access etc;
- 6. Linkages with cotton and textile producing countries;
- 7. Training, skill development, research for quality improvement and productivity enhancement throughout the production/value chain;
- 8. Management of textile quotas; and
- 9. Administrative control of:
 - i. Federal Textile Board, Lahore
 - ii. Textile Commissioner's Organization, Karachi
 - iii. Textile City (Projects), Karachi/Faisalabad;
 - iv. National Textile University, Faisalabad;
 - v. All textiles related TDAP/EDF funded institutes concerned with skill development in various sub-sectors of textile industry;
 - vi. Garment City Projects at Lahore, Faisalabad and Karachi;
 - vii. Pakistan Cotton Standards Institute, Karachi.
 - viii. Pakistan Textile Testing Laboratory, Faisalabad.



ORGANIZATIONS WORKING UNDER TEXTILE DIVISION

TEXTILE COMMISSIONER'S ORGANIZATION (TCO), KARACHI

The Textile Commissioner's Organization (TCO), with the status of an attached department under the Textile Division, Ministry of Commerce & Textile, is headed by the Textile Commissioner. TCO was created in November 1973 and its separate budget was allocated in July 1974. TCO provides every possible support to the Textile Division on the matters related to Textile Sector of Pakistan. It also acts as a bridge between Textile Sector and Government and takes up the problems of Textile Sector to Government for their solution.

The performance of the Textile Commissioner's Organization for the Period 01-07-2018 to 30-06-2019 is given as under:

STITCHING MACHINE OPERATORS TRAINING PROGRAM (SMOT-III)

Stitching Machine Operators Training (SMOT) Scheme was launched in June 2006 by the Ministry of Textile Industry under Textile Skill Development Board (TSDB) and the Textile Commissioner's Organization as its Secretariat. The concept was to attract Textile Industry to organize in house training programs in garment units, support them on cost sharing basis and motivate them to keep on running training scheme for availability of skilled workforce.

The Phase-III of the Stitching Machine Operators Training (SMOT) was approved during the 12th & 13th meetings of the Textile Skill Development Board convened on 14-01-2019 & 26-01-2019. The modalities of the SMOT-III Program are given as under;

- i. Course durations = 2 months for both industrial units and Textile related EDF Funded institutes
- ii. Maximum Batch Size will be 30 Trainees
- iii. Trainee to trainer ratio will be 30:1
- iv. Trainee's stipend of Rs:5000/- will be paid by the TSDB Secretariat
- v. Trainer's salary of lump sum would be Rs: 35,000/ per month & will be paid by the TSDB Secretariat. In case of institutes, Rs.1000/- per trainee per month will be paid to the textile related EDF Funded institutes to cover overhead expenditure.
- vi. As training is aimed for female workers, so collection points are necessary, as institutes have no funds for such arrangement, therefore Rs:1,000 / Trainee may be given to the Institutes while Textile Units will arrange at their own
- vii. Instead of Monitoring through personnel, it will be carried out through Biometric / Facial recognition system.

- viii. The participating unit would designate a SMOT Contact Person in the factory for coordination.
- ix. TSDB Secretariat will nominate SMOT Officers at Karachi, Lahore & Faisalabad to perform snap visits.
- x. Payment to trainees through easy paisa.

The Action Plan for launching of SMOT-III Program was prepared and accordingly all tasks were completed under intimation to the Textile Division. The details are given as under:-

- After approval of SMOT- III Program in 12th & 13th meeting of TSDB, Agreements with selected Textile Training Institutes & Units were signed.
- An Advertisement for seeking applications from the Trainees / Trainers for SMOT-III was published on 20th February, 2019 along with list of selected Textile Training Institutes & Units located at Karachi, Lahore & Faisalabad.
- Application Form for Trainees & Trainers along with eligibility criteria of Trainers was uploaded on TCO website.
- Advertisement Campaign was carried out & Pena Flex Banners were placed at the prominent places and Handouts were distributed by the TSDB Secretariat.
- TCO-SMOT Focal Person & TCO-SMOT Officers have been nominated.
- Selection Committee was constituted to examine the applications of Trainees & Trainers
 received in Textile Institutes / Units & made the selection after conducting the
 interviews.
- Interviews of the Trainees & Trainers were conducted by the Selection Committees & process of selection has been completed.
- As per Instructions of the Textile Division TCO officers were nominated to act as Evaluation officers till the appointment of regular incumbents.
- SMOT-III Program has been launched w.e.f 20th March, 2019.
- As per decision of the 13th TSDB meeting, an amount of Rs.10,000 has been paid to the Textile Training Institutes for the purchase of Biometric Facial Recognition System for effective monitoring.
- Selection Committee for contractual vacant posts was constituted.
- As per decision of the 13th TSDB Meeting the Evaluation officers, Accountant and Driver have been appointed for the SMOT-III Program.
- The Weekly Evaluation of the all participating Textile Training Institutes and Units were being conducted.

Textile Cess Collection:

The Organization is also given additional responsibility in 1983 of Cess Collection from the Textile Mills for the National Textile University, Faisalabad. The Textile Commissioner was appointed as the Cess Collector. During the period Jan 2018 to Dec 2018, TCO collected the Cess Rs.11,288,300/- against the Target of Rs.11,250,000/- for the year 2018. The Textile Cess collected and disbursed to National Textile University for the last (06) years is given as under:-

The present secretary after a series of meetings for enhancement of cess and directed TCO to enhance the cess to a target of Rs.13 Million on existing rate and on the other hand he also conducted meeting to enhance the rate and directed to extend it to the other sectors as well. TCO in compliance held a series of meetings and constituted a committee comprising Engineers/officers from TCO and NTU. The committee concluded and rationalized cess rate for existing & other sectors of Textile industry.

The summary was sent to the Textile Division for amendments in cess order so as to incorporate other sectors in cess net. Moreover, in compliance of the directions of Secretary, Textile Division, TCO conducted physical survey & obtained list of Mills from FBR, SECP, and SBP in order to reconcile and enhance cess base and to bring new Mills in cess net. In effect a tangible number of undeclared & new mills were brought in the Textile Cess Net.

As per direction of the honorable Secretary (Textile Division), Ministry of Commerce and Textile, the target of the Textile Cess collection for the year 2019 was increased to Rs.13 Million as compared to the target Rs. 11 Million for the year 2018 which is 18.2 % more than the target fixed for the preceding year in existing rate.

In order to achieve the above target, the steps/measures taken are given as under:-

- Data of new mills and expansion of machinery for last five years acquired from relevant government organizations like SECP, FBR and relevant provincial departments
- Reconciliation of the data with the statistics section of TCO and information retrieved from websites
- Physical surveys, Inspection/visits of mills in all hubs of Textile Industry and meetings in the head offices of the mills
- Acquisition of the updated data through correspondence and visits
- Frequent serving of assessment form and recovery Notices through currier.
 With the above steps, the Textile Cess collected during the period Jan-June (2019) is
 PKR 11,021,707/- as compared to the PKR 8,918,079/- for the same period of the

preceding year i.e. an increase of PKR 2,103,628/- enhanced or 23.58% increase in the Textile Cess Collection in five months period.

Technology Up-gradation Fund (TUF): Scheme

The Ministry of Textile Industry issued 'Technology Up-gradation Support' Order 2010 through Notification No.3 (18) TID/10-P-I dated 5th April, 2010. According to the notification, the Federal Government will reimburse 50% of mark-up subject to a maximum of 5 percentage points p.a., whichever is less for a maximum mark-up support of Rs.50 million per annum for each sub-sector. The Federal Government may provide up-to 20% investment support to SMEs dfor import of new plant and machinery up-to Rs. 10 million. The Federal Government may also provide 5% investment support to Non-SMEs/other eligible projects, against imported new plant and machinery through their own sources. However, maximum support to one company will be Rs. 50 million only for each sub-sector.

This support will be available to SMEs as defined under the SBP Prudential Regulations for SMEs. The scheme was effective from September 01, 2009 up to June 30, 2014. Disbursements under this Order will continue for the duration of loans till June 30, 2024.

The repayment period shall not exceed ten years including grace period as may be allowed by the SBP.

The Textiles Policy states that the units availing the Technology Up-gradation Scheme would be required to establish that their investments will have at least one of the following characteristics:

- i. Improve overall technological configuration of the sector;
- ii. Remove critical imbalances in the value chain; or,
- iii. Achieve compliance with international standards

TCO along with NTU was tasked by MINTEX to accomplish Inspection of machinery under TUF Scheme in compliance with instructions.

TCO being TUF Coordinator issued inspection schedule and machinery inspection of Textile Mills was initiated w.e.f 29th January, 2016. TUF schedule was issued on weekly basis to concerned inspection teams comprising of experts from Textile Commissioner's Organization, National Textile University (NTU) and concerned Association.

23 Textile Units situated at Punjab, Sindh, KPK & Baluchistan have been inspected by the teams during the period 01st July, 2018 to 30th June, 2019 and no further unit is pending for inspection under above Scheme.

Statistics & Data Base Centre at TCO:

The Textile Commissioner's Organization (TCO), Karachi is entrusted for collection and dissemination of information relating to production and consumption of Textile raw materials and finished products data under General Statistics Act and SRO 11(KE)/79.

Keeping in view of the functional and data management system, the following assignments are completed/in process in Database Centre;

- Publication of annual report on performance of Textile Industry 2017-18, and annual report on performance of Textile Industry 2018-19 is in process (the report offers comprehensive overview and statistical data on Textile Industry of Pakistan).
- TCO-01 Online Statistical Performa (planning and redesigning of the Performa along with various reports on different online formats).
- Inclusion of Towel sector in TCO-01 Online statistical Performa.
- Providing Material/Statistics for Economic Survey of Textile Industry.
- Providing production data to MIS cell of the Ministry of Industries.
- Providing data on Textile Sector to Provincial Govt. as & when required.

Revival of Pakistan Textile City Limited (PTCL)

According to Economic Policy 2004-05, Pakistan Textile City Limited (PTCL) came into existence. It was a mega project comprising of 1250 acres of land. It was envisaged to achieve huge socio-economic targets as under.

- Additional capacities
- Exportable surplus
- Move to higher value addition
- Increased technical skills aggressive marketing and management
- Enter into joint ventures with long term engagement to principal buyers.
- Mega jobs creation help fight poverty and contribute to social responsibilities.

Un-luckily the previous regime decided to wind up the project hence was in limbo since 2017, but the present Government took initiative to revive this Mega Project. Textile Commissioner's Organization was tasked to facilitate and coordinate for its revival arrangement to conduct audit. TCO with its limited resources provided all facilities to Pakistan Textile City including office space, transfer of record & facilitated the federal commercial audit. The audit has been completed, preliminary draft audit report has been forwarded and PTCL is in process of revival.

Karachi Garment City Company (KGCC)

The Secretary Textile also advised TCO to work on this mega labour Intensive Project. The 1st step was to mutate the 300 acres land from Sindh Government to KGCC as there was a shortage of funds, therefore, the project was unable to pay the federal & provincial Taxes.

As per current taxation laws, Millions of rupees were required to register the land in the name of KGCC. However, TCO aggressively pursued the matter and with patronage of worthy Secretary (Textile Division), it remained successful to acquire the status of NPO from FBR, which saved millions of rupees of KGCC, meanwhile getting status of NPO from Sindh Government is also in process.TCO is continuously perusing the relevant department of Sindh Government in order to pave the way to initiate this highly labour intensive and export oriented project.



Retrieving of Plot No. H/9 measuring 1 Acre aimed to establish Textile Training and Research Centre at SITE Super Highway, Karachi



1 acre Plot Situated in phase-II SITE Super highway was purchased in 2005 and with the inception of Textile Ministry, control of the land was given under control of Ministry. The plot remained unattended since long but the present secretary took initiative and order TCO to retrieve the plot as it was encroached and illegally occupied by land mafia.

TCO took drastic measure despite huge pressure from local influential people and retrieved 0.8 acre of plot and remaining 0.2 acre is under litigation.

It has been proposed that as the mega projects like Garment City and Textile City are on the stage of revival, the plot may be utilized for Research & Textile Testing purpose for these Textile Clusters.

Textile Training Institute Management Board (TTIMB)

The Textile Training Institutes Funded from EDF were placed under the administrative control of Ministry of Textile Industry vide Notification No.8(81)/TID/05/P-II dated 21-01-2008 entry at Serial No.29 A(9) (vii) of schedule II and Federal Government constituted a Common Governing Board titled as "Textile Training Institute Management Board" (TTIMB).

Textile Commissioner's Organization, Karachi is acting as a Secretariat of the Board. In order to discuss the issues faced by Textile Training Institute, eight meetings of the TTIMB have been convened so far.

Physical Survey for the financial requirement/analysis of all (07) EDF institutes was carried out by the TCO officers and consolidated statement of the required funds have been prepared and submitted to Textile Division for further necessary action.

Resolved the Problem of Acute shortage of Hydrogen Peroxide

TCO received complaints from Textile Industry on account of shortage of hydrogen per oxide. In order to review the factual position and to resolve the problem of acute shortage of Hydrogen Peroxide in the country, various meetings were convened with all stakeholders.

In this regard, a meeting with Associations (APTPMA & TMA) and local Manufacturers of Hydrogen Peroxide for Textile Industry were held on06-08-2018 to make sure the adequate supply of Hydrogen Peroxide to Textile Industry by the manufacturers.

In order to revive the sick units and for better interaction with Textile Industry, Textile Commissioner's Organization, Regional Office, Faisalabad has been established. Regional Office Faisalabad is playing an important role by conducting Physical surveys of textile units for the (enhancement/enrolment of spinning & weaving sectors) Cess collection and in implementing the SMOT-III Scheme.

PAKISTAN COTTON STANDARDS INSTITUTE (PCSI) KARACHI



Introduction:

Pakistan cotton is inherently of good quality. But, absence of quality control measures, improper handling and ginning practices, non existence of a pricing system based on premium and discounts, non-implementation of recognized grading system leads to depreciation of the value of raw cotton and the resulting textile products and country is not getting real intrinsic value of its silver fibre from the international market.

Being cognizant of these problems, the Government decided to introduce standardization of cotton to bring it at par with the internationally accepted standards for improving the competitiveness of Pakistan's cotton as well as ensuring better returns to cotton growers, ginners, spinners, exporters and the national economy. Cotton Standardization Ordinance 2002 was promulgated to establish Pakistan Cotton Standards Institute and to promote the quality control of cotton.

2. Policy Frame Work

Government of Pakistan realizing the importance and role of cotton sector in national economy is making serious and continuous efforts to meet the up-coming challenges which the international competition has forced for doing things properly and up to the international standards.

Textile sector of the country on which national economy heavily relies is demanding upon to control costs, reducing wastages and improving productivity levels in terms of quality, for attaining a valuable and sustainable position in the Global cotton market. Pakistan textile sector direly needs for standardized and clean cotton.

Keeping in view the emerging competitive market and the implementation of post WTO arrangements resulting in quota free market, Pakistan has accordingly reorganized its policies in order to fetch the real share from the international cotton market.

Henceforth, in order to address the problem government framed a policy to upgrade the Pak. cotton quality to bring it at par with international standards and in the light of government policy PCSI prepared a frame work to achieve result oriented goals through the implementation of cotton standardization system.

3. Goal, Vision and Mission

I. Goal:

Enhancement of Pak Cotton Quality withrough the implementation of Cotton Standardization System to meet the challenges and requirements of quality in the national/international market, for the production of high quality standardized and clean cotton following goals have been set:

- i. Improvement of Picking/Handling/Ginning practices.
- ii. Instrumental Evaluation of Cotton.
- iii. Human Resource Development.
- iv. Incentive Based Marketing System.

II. Vision:

- i. Enhancement of Pak cotton quality through cotton standardization program.
- ii. To bring Pak cotton at par with international standards.
- iii. To ensure real intrinsic value of Pak cotton and its made-ups from the international market.

III. Mission:

- i. Education/ Awareness Campaigns.
- ii. Human Resource Development.
- iii. Proper picking and handling procedures.
- iv. Improved ginning practices.
- v. Minimizing contamination.
- vi. Incentive Based Marketing System.

4. Progress / Activities during 2018-19

i. <u>Training Programmes:</u>

i) Cotton Selectors Training Course

Cotton Selectors Training Course is one of the popular programmes and has significant response from public & private sector. This is a four week training programme conduct at PCSI Head Office Karachi and Regional offices Sukkur and Multan. One of the main objectives of PCSI is to train new generation of skilled persons in the skills of Cotton Classing and Grading. PCSI is regularly conducting training programmes in Cotton Grading/Classification and instrumental evaluation of cotton. The programme provides ample opportunity to the participants to get training in the basic skills of cotton classification and grading. Till date over

2349 personnel have been trained through this programme. During 2014-15, 102 participants benefited from the training programmes. In the light of the directives of PCSI Board of Directors the number of training programmes has been increased from two to six.

5. Cotton Fiber Testing Services

Among the ten cotton fiber testing laboratories established by PCSI in the districts of Sindh at Karachi, Sanghar and Punjab at Rahim Yar Khan, Multan, Vehari, D.G.Khan, Sahiwal, Faisalabad are fully operational and providing high quality testing services to the stakeholders of cotton. This has laid a strong foundation for developing cotton quality culture in the country and help in shifting over the present cotton marketing system to a quality based marketing system on the basis of grade, staple length and other fiber properties subject to premium and discount. These labs provide comprehensive range of testing facilitates under one roof.

6. Cotton Fiber Testing Services To National Textile University (NTU), Faisalabad

The Textile Industry is committed to facilitate the textile research institutes of the country through modernizing infrastructure and logistic support to undertake research and development work in the sector PCSI Cotton Fiber Testing Laboratory, Faisalabad equipped with HVI 1000 classing and Shirley Analyzer Machines MK II UK is providing testing facilities to National Textile University, Faisalabad to facilitate researchers, scientists, textile students of the university besides its routine commercial testing services to the public and private sectors.

7. Development of PCSI Official Website

PCSI has developed and lunched its official website www.pcsi.gov.pk.

8. Targets and Achievements during the year 2018-19

Target set and the achievements made during the year 2018-19 for the production of standardized and clean cotton and to bring the Pak cotton at par with international standards are as follows:

i) Education awareness campaigns.

Education and awareness campaigns are being regularly held to create quality culture in the cotton sector. For the purpose in the year 2018-19 informative literature regarding proper picking, procedures handling and ginning practices have been prepared in regional and national languages and provided/ distributed.

ii) Cotton Selectors' Training Course:

During 2018-19 five Cotton Selectors Training Courses have been held at PCSI Regional Office, Multan in the months of August 2018 and February 2019 and one Cotton Selector Training Course at Regional Office Sukkar in the month of March, 2019 and two Cotton Selectors Training Courses held at Head Office, Karachi in the months of July, 2018 and April 2019. Through these courses 47 personnel from public and private sector have been trained in the skills of cotton classing and grading.

(vii) PCSI & KCA COLLABORATIVE TRAINING PROGRAM:

PCSI arranged two calendar week Cotton Grading and Classing course at Cotton Exchange Building, Karachi in collaboration with KCA from 4th March 2019 to 15th March, 2019. Stakeholders across the board, particularly Textile value chain, Exporters, Ginners, Buyers, Brokers from all over the country participated in the course. PCSI technical officers (Cotton Classers) imparted the training. During the course there were practical as well as theoretical classes arranged for the trainees besides a visit each to a textile mill (AL-Karam Karachi) and PCSI Cotton Fibre Testing Lab, Karachi to facilitate the participant for gathering enhanced knowledge on the spot. 40 participants attended the Course.

(viii) HUMAN RESOURCE DEVELOPMENT

PCSI strongly believes in human resource development. During 2018-19 PCSI trained 06 officers in various disciplines of Cotton Technology, Computer Skills, Administration and Finance.

9. <u>Issues and Challenges</u>

Pakistan Cotton is inherently of good quality but due to contamination and non implementation of cotton standardization system the commodity is not fetching its real intrinsic value from the international market. To achieve the same the only methodological approach is the implementation of Cotton Standardization Ordinance 2002 along with the amended Cotton Control Act, 1966 for the production of high quality clean cotton with letter in spirit across the board. This has direct impact and immediate bearing on the entire chain of value addition till the final made-ups, thus providing substantial boost to the national exchequer.

10. Future Out-look/Plans:

- i. Implementation of amended Cotton Control Act, 1966 to control contamination in cotton and mandatory marking of grade and staple length on each bale by the ginners.
- ii. To shift over the present cotton marketing system to a quality based marketing system on the basis of grade, staple length and other fibre properties subject to premium and discount.
- iii. Establishing a network of Cotton Fibre Testing Laboratories equipped with HVIs at district level.
- iv. Campaigns for producing Standardized and Clean Cotton.
- v. Strengthening of PCSI with men and machine.
- vi. Launching of education/awareness campaigns to develop a quality culture in the country through print/electronic media and by conducting increased number of training courses.

TEXTILE / GARMENTS CITIES

KARACHI GARMENT CITY COMPANY (KGCC)

Karachi Garment City is a project of Textile Division spreading over an area of 300 acres of prime industrial land situated about 55 Kms from the city centre and located next to Arabian Sea Country Golf Club, in the vicinity of Port Qasim. The project is run by Board of Directors, Karachi Garment City Company (KGCC) comprising members both from public and private sectors. KGCC is registered with SECP as a Company under Section 43 of Companies Ordinance, 1984.

Initial planning, designing and preparation of engineering drawings of the project have been done by M/s. National Engineering Services Pakistan (PVT) Limited as consultants of Karachi Garment City Project. M/s. Deloitte Yousuf Adil, Chartered Accountants were external auditors of the company.

Karachi Garment City Project is planned to have state of the art infra-structure facilities such as roads network, communication system, security, water and drainage system, dependable industrial power generation plant, internationally standardized buildings and industrial plots to establish ISO 9000 compliant clothing and made up manufacturing factories. In addition, the project also envisages setting up of washing zone, training institute, library / research centre, testing laboratory, overhead and underground water tanks, effluent water treatment plant, firefighting plant, administration block & auditorium, dispensary, shops / banks, warehouses, container yard, transport / terminal parkings and mosques / parks etc.

Land Utilization Department (LUD), Board of Revenue, Sindh allotted 300 acres of industrial land at NC No. 98 of DehPipri, Karachi in the Port Qasim area to Karachi Garment City Company on 29th March, 2007 and an amount of Rs. 300 million received from Export Development Fund (EDF), Government of Pakistan was paid to Government of Sindh on 23rd January, 2008, as full cost of land.

After expiry of tenure of existing members of KGCC-Board on 31.10.2018, in pursuance of Public Sector Companies (Corporate Governance) Rules, 2013, The Federal Government has reconstituted and notified the Board of Directors of KGCC for a period of three years on 10th April, 2019. Exemption on Payment of Lease Charges

Textile Division and KGCC-Board of Directors time and again requested Chief Secretary, Sindh and Secretary, Industries & Commerce Department, Government of Sindh to grant waiver/exemption to Karachi Garment City from payment of lease and mutation charges on the plea that project is fully financed and owned by Government of Pakistan and entitled for such exemption under the relevant Act. Government of Sindh has not taken a decision on our application in the matter until now.

BOR, Sindh has assessed lease charges applicable on 300 acres land allotted to Karachi Garment City On 04.05.2017, as follows:

Delay in taking decision by Government of Sindh on grant of exemption was brought into the notice of Ministry of Commerce & Textile (Textile Division) who approached EDF Board to grant additional funds of Rs 558.401 million to make full payment of lease charges and sign the lease agreement with Government of Sindh. Decision of EDF Board is awaited.

No Profit Organization (NPO) Status

KGCC's application for NPO status was pending with Regional Tax Office, Karachi for the last more than five and half years. This position was reported to Ministry of Commerce & Textile (Textile Division). With help, efforts and active support of Ministry of Commerce & Textile (Textile Division), no profit organization (NPO) status has been finally granted by Federal Board of Revenue, Govt. of Pakistan to the company on 29.03.2019 and also exempted u/s 236K of the Income Tax Ordinance 2001 on payment of tax on account of payment of purchase/transfer of land acquired from Govt. of Sindh.

On the basis of NPO status and exemption certificate u/s 236K granted to the company BOR, Sindh has been requested by Federal Government on 04 April 2019 to transfer title of land without payment of both provincial and federal taxes.

Development Concept of Project

The project is envisaged to be completed in 5 phases. In the 1st phase comprising of 2 parts, a land parcel of 52.25 acre will be developed with essential infrastructure of all utilities like Roads, Electrical, Water Supply, Sewerage & Gas including administrative building etc. In the later phases each land parcel will be developed for local and foreign entrepreneurs who require land parcel in different sizes from 0.5 to 2 acres and multiples thereof including supporting infrastructure of roads, sewerage & water supply, drainage, effluent chemical & sewerage treatment, captive power generation, adequate parking for trailers etc. Such plots will not be available for outright sale but offered only on lease basis.

PC-1 of 1st phase

PC-1 of 1st phase of the project with estimated total capital cost of Rs. 1,549.14 million (inclusive of lease charges) was sent to Textile Division on 17 March for approval/grant of requisite funds under PSDP.

Code of Corporate Governance for Public Sector Companies

The Securities and Exchange Commission of Pakistan (SECP) vide its SRO. 180(1)/2013 dated March 8, 2013 issued Public Sector Companies (Corporate Governance) Rules, 2013 which are applicable to all public sector entities for the year ending June 30, 2014 and onwards.

As commercial operations of the project did not start during the year, it was practically not possible for the Company to frame / formulate all the required policies and implement all requirements under the Rules. Nevertheless, company will file statement of compliance with SECP for the year 2018-19.

LAHORE GARMENT CITY COMPANY (LGCC)

The Government of Pakistan, in the Trade Policy 2003-04, had announced setting up of three Garment Cities in Karachi, Lahore and Faisalabad.

Legal Status of the Department /Organization

The Lahore Garment City Company was incorporated on 16th September 2004 under section 42 of Companies Ordinance, 1984 with Registrar Joint Stock Companies, City District Government Lahore. Total Area of LGCC is 19.34 acres.

Major Function

The underlying objective was to reduce the capital outlay of Garment Manufacturers and provide them with a built up space, fully compliant and equipped with state of the art facilities where they can establish their units by avoiding the lengthy process of buying land and then constructing factories thereon.

FAISALABAD GARMENT CITY COMPANY (FGCC)

Faisalabad Garment City Company was established as Public Sector Company under Ministry of Textile Industry (Textile Division) in 2006 and was registered under Section 42 of Companies Ordinance 1984 / Companies Act, on 8th May, 2006.FGCC possesses 38.9 acres of land (including 10 acres yet to be transferred to FGCC by Government of Punjab through FEDMC). The total area is surrounded by boundary walls with main gate and security arrangements.

Federal Government sanctioned an amount of Rs. 590.818 million from PSDP funds and Rs.100 millions from EDF as one time grant.

FGCC has constructed two buildings of six floor each from PSDP grant mentioned above which were completed in 2010 and 2012. Both buildings are rented out to garment manufacturing units and expenditures of the Company (FGCC) are met out from the rental income of these buildings. No financial budget is given to FGCC by Federal Government. FGCC is therefore self-sustainable Public Sector Company and financially sound.

The mandate of the Company (FGCC) is to boost up exports of garment made-ups from Pakistan and to support garment manufacturers / exporters through training of skilled work force.

For this purpose, a Female Exclusive Training Institute (FETI) was established in November, 2017 which becomes operational in June, 2018 after meeting the prerequisite requirements. JICA has provided 58 stitching machines of different kinds which have been installed in the said institute under the supervision of JICA experts.100 female students have been trained so far and placed on jobs in various garment manufacturing companies and some of them are on self-employment. Trained staff has been recruited with the help of JICA experts for imparting training to FETI students. Students and one trainer are being paid stipends through SMOT-III Program at the rate of Rs. 5000/- per student per month and Trainer is paid Rs. 35000/- per month through this program. The duration of this project is 24 months ending on 14th November, 2019. Students are given pick & drop facility by the FGCC:

FETI is the only Female Training Centre in the public sector / departments of the Federal Government, which is successfully imparting training to the female work force and this is a success story for FGCC.

JICA also arranged a 15 days training program in Japan (Tokyo) from 7th July, 2019 to 21st July,

2019 to six persons of FGCC / FETI for skilled development training on modern techniques to operate sophisticated stitching machines used for garments manufacturing.

Exports of garments manufactured by units established in FGCC buildings during 2018-19 is to the tune of 70/- million US dollars.

About six (06) thousand skilled workers are on job and 52% of them are female skilled workers working in different units.

An amount of Rs. 135.5 millions are in FGCC bank accounts as on 30th July, 2019 which shows the degree of financial sustainability.

A Medical Center is also functional in FGCC since 2015.

A Mosque has also been built in the premises of FGCC.

An auditorium with the capacity of 300 seats is also made operational in Admin Block of FGCC.

A Day Care Centre has also been established with the support of Government of Punjab. Government of Punjab will bear expenditures for one year and after one year the Day Care Center will be easily managed by FGCC itself. The Day Care Centre is the need of the day as a good number of women employees / workers and couples are in jobs and they need facilitation as per Government policy.

7000 small trees have been planted under the vision of the Prime Minister under Green and Clean Pakistan Move on 16 acres of land.

FUTURE PLANS OF FGCC:

A self-financed project of Rs. 184.75 million (estimated) has been approved by DWP and the process of hiring of consultant firm for consultancy services is almost stood finalized as per recommendations of DWP made in its meeting held on 25th January, 2019. An agreement with the selected consultant firm has been signed after meeting formalities. The work assignment as per TORs is about to start shortly. Textile Division has also been updated separately in this regard through a formal letter. The ground breaking ceremony of this project was inaugurated by the Advisor to the Prime Minister on Commerce and Textile and Federal Secretary Textile Division a few months back.

Another project of an estimated cost of Rs. 1060/- million has also been approved in principle in

Pre-CDWP meeting held in Ministry of Planning, Development and Reforms, Islamabad.

Pursuant to the advice of Ministry of Planning, Development and Reforms received through Textile Division for hiring of consultant firm is prerequisite. Tender for hiring of consultant firm was uploaded on websites of FGCC and PPRA. In response, high priced bids were received which were deferred as a result of decision taken in the meeting of Procurement / Tender Opening Committee being not acceptable. Representative of Textile Division was also present in the said meeting and was a part of the said decision. The matter was taken up with the Textile Division for advice. Textile Division referred the matter to PPRA which advised to re-advertise the tender notice. The matter has again been discussed in Procurement Committee Meeting held on 27th August, 2019 and estimated / tentative procurement plan has been agreed to in the presence of the representative of Textile Division. This will be got approved in the next BOD meeting. This has also been shared with Secretary Textile Division by Chairman FGCC over phone.

• Further development projects in FGCC will be planned on completion of the above mentioned two development projects.

ISSUES RELATED TO FGCC ALREADY INTIMATED TO TEXTILE DIVISION AT TIMES FOR TAKING UP WITH THE LINE FEDERAL MINISTRIES AND PUNJAB GOVERNMENT:

- Gas connection for Category –B Building (Phase-I) and other Buildings to be constructed at FGCC in future. Fee / charges have already been paid to SNGPL through bank challan.
- Registry of Land in the name of FGCC, Faisalabad.
- Carpeting of bypass road in front of FGCC.

PROPSAL FOR FURTHER EXPANSION / IMPROVEMENT OF FGCC:


- The Federal Government (Textile Division) may take up the matter of construction of labour colonies meant for skilled labour, so that garment manufacturers may avail their services nearest to their industrial units and transport facilities can easily be provided to the skilled labour engaged by them.
- Federal Government may explore the international markets for consumption / export of garment made-ups.
- Federal Government may also ensure standard and market based salaries, free
 medical facilities, provision of foods on subsidized rates and death compensation
 package to the skilled work force working in their respective industrial units and
 support their children in getting quality education.



PROPSAL FOR IMPROVEMENT IN OVERALL GARMENT SECTOR TO BOOST EXPORTS:-


- This is a policy matter. All stakeholders of the Federal Government may sit together and prepare a plan in consultation with the experts and leading textile exports associations etc.

TEXTILE RESEARCH & ADVISORY CELL

Textile Sector is the lynchpin of Pakistan's economy and has the longest production chain, with inherent potential for value addition at each stage of processing, from cotton to ginning, spinning, fabric, processing, made-ups and garments. In the financial year 2018-19 Textile Research Wing made every possible effort to promote textile sector with special focus on exports. The Textile Research Wing held number of meetings with the textile associations including meeting of Federal Textiles Board under the chairmanship of Minister for Commerce. The proposals were developed and submitted during the course of financial year and the following measures were taken by the government to restore the competitiveness of textiles value chain.

- Release of approx. Rs. 45 billion for the Duty Drawback Schemes during 2018-19.
- ii. RLNG at \$6.5/ mmbtu for export oriented zero-rated sectors;
- iii. Gas Price has been rationalized at Rs. 786 / mmbtu for export oriented sectors.
- iv. Electricity at US Cents 7.5/kwh for export oriented sectors.
- v. No Custom Duty on import of Textile machinery.
- vi. Regulatory Duty on Cotton Yarn is reduced to 5% from 10%
- vii. The custom duty, additional custom duty and sales tax on imported cotton were withdrawn from February 1st, 2019 to 31st July, 2019. The duties are re-imposed from August 2019 in lieu of domestic cotton arrival
- viii. Import of high quality cotton from Afghanistan/CARs through Torkham border has been allowed. Permanent customs station is being established.
- ix. The Long Term Financing Facility was continued at 5% for the year 2018-19 to attract investment in the textiles value chain.
- x. The mark-up rates on Export Refinance Facility, was brought down to 3.0%.
- xi. Duty free import of textile machinery was continued in 2018-19.
- xii. Uninterrupted electricity and gas was ensured for the textile sector. Further, RLNG was provided to Punjab based textiles value chain
- xiii. Technology Up-gradation Fund (TUF) Scheme was continued.

The performance of Textile Division during FY 2018-19 remained satisfactory. No doubt overall textile exports remained \$13.29 billion during July-June 2018-19 with decrease of -1.42%, however, in terms of quantities the exports has increased significantly, especially:

- Knit garments exports increased by 6.92% in terms of value and in terms of quantities increased by 15.52%
- Woven garments exports in terms of value increased by 3.03 % and in terms of quantities increased by 32.77%.
- Bed wears exports increased by 0.06% in value and 8.18% in terms of quantities.

PSDP PROJECTS

1) 1000 Industrial Stitching Units.

PSDP project 1000 industrial stitching units started in 2018-19 after first release of fund from planning Division in June 2018-19. All preliminary activities for execution of the project were performed in FY 2018-19. The project is functional and stitching units will be awarded in FY 2019-20.

2) Faisalabad Garment City Phase II and Phase III

Faisalabad Garment City Phase II and Phase III were included in development plan of Textile Division for 2018-19. Planning Commission removed allocation of Phase-II of the project, Costing Rs.889 million, due to rationalization of PSDP 2018-19. However, Foundation stone of the project Faisalabad Garments Phase III a sell financed, factory building project was laid down in 2018-19. The total cost of the project is Rs.184.75 million which will be completed in 03 years. The building will be rent out to garment manufacture which will reduce their capital outlay for carrying out business activities.

3) <u>Standardization System For The Production Of High Quality Standardized Clean Cotton:</u>

The project "Standardization System for the Production of High Quality Standardized Clean Cotton" was approved by DDWP of Textile Division in FY 2018-19. However Planning Commission withdrew fund allocation for this project due to rationalization of PSDP.
