I. Introduction

Mindful of the importance of qualified human resources for social advancement and sustainable development, the Islamic Development Bank (IsDB) has been very keen from the outset of its establishment to focus on human capital development alongside its mainstream development financing activities.

In recognition of the vital need to develop the human resources of the Muslim communities in non-Member Countries (non-MCs), IsDB launched its undergraduate scholarship programme (SP) in 1983 under the title Scholarship Programme for Muslim Communities (SPMC).

Capitalizing on the experience of a decade of the SPMC, IsDB decided to establish the Merit Scholarship Programme (MSP) for Ph.D. studies and post-doctoral research in applied science and high technology to strengthen the scientific, technological and research capabilities of institutions in Member Countries (MCs), which was launched in 1992. Later, the Master of Science Scholarship Programme (M.Sc.) was launched in 1998 as a feeding programme for the MSP, realizing that 20 of the Least Developed Member Countries (LDMCs) could not benefit from the latter.

In IsDB's Realigned Strategy 2023 – 2025, the Bank dedicated an entire pillar to the support of comprehensive and inclusive human capital development. Through this pillar, IsDB aims to help MCs and Muslim communities in non-MCs to address these challenges

with capacity-development initiatives, including scholarship programmes. It is also an important component of IsDB's efforts to promote economic development and shared prosperity through the global development of human capital by investing in education.

Currently, there are four programmes offered by IsDB:

1. IsDB Scholarship Programme for Muslim Communities in Non-Member Countries (SPMC)

The SPMC was launched in 1983 to enable academically meritorious and financially impoverished young Muslim students from Muslim communities in non-MCs to undertake undergraduate studies in medicine, engineering, computer sciences, information technology, agriculture, and other related fields in their own countries or the IsDB MCs.

2. IsDB Master of Science Scholarship Programme (M.Sc.)

The M.Sc. Scholarship Programme was launched in 1998 to assist 20 IsDB LDMCs in the development of their human capital, especially in science and technology, which are both relevant and necessary for their development.

3. IsDB Merit Scholarship Programme for High Technology (MSP)

The implementation of the Merit Scholarship Programme commenced in 1992. The programme is dedicated to advanced studies and/or research (3-year Ph.D. and 6-12-month post-Doctorate) in 16 applied science and high technology areas deemed necessary for the development of the MCs.

4. IsDB-ISFD Scholarship Programme

The IsDB-ISFD Programme was launched in 2019 by IsDB and the Islamic Solidarity Fund for Development (ISFD), with the specific aim of reducing poverty in 21 Least Developed IsDB Member Countries (LDMCs). The programme provides educational opportunities for academically meritorious and financially impoverished young men and women from 21 LDMCs to pursue bachelor studies in medicine, engineering, agriculture and other related fields or a technical diploma at a public institute in their home countries or in other IsDB member countries.

Guidance & Counselling Activities

IsDB graduates are the key to deliver the impact of socioeconomic development programmes in their countries. Therefore, IsDB felt the need to motivate students to fulfil the IsDB dream of not only producing successful graduates but also developing them as good citizens and competent professionals capable of achieving IsDB's corporate objectives regarding the development of their communities and countries.

As a result, IsDB initiated a support programme called **"Guidance and Counselling Activities"** for students involving the appointment of honorary counsellors to support and guide students, organize annual seminars for group learning to support the students'

personal development, which includes mentorship and learning meetings, educational development seminars and tutoring during vacation.

The programmes are formally announced every year in February for the September student intake. The following schedule is drawn on the basis of academic calendars of universities and institutions around the world where IsDB students will study.:

III. Administration of the Programmes

The programmes are managed by the Special Assistance Division (SpAD) under the supervision and guidance of an Internal Executive Committee (IEC) composed of members of the IsDB Senior Management and chaired by the IsDB Vice President, Operations. The SpAD facilitates the applications, selection process and placement of students. It also undertakes all matters related to the administration and financial support of the students while they are studying and monitors their academic performance to ensure timely completion of their studies.

Applications for SPMC, M.Sc. and IsDB-ISFD programmes are reviewed by the IEC to identify candidates with the highest potential for final approval by the Chairman. Applications for MSP are submitted for a second phase of review by a panel of eminent scientists to ascertain the scientific and development relevance of the field of study and to assess the overall qualifications of the applicants. Recommendation of candidates for final selection is made by the IEC and given final approval by the Chairman of the IEC.

2) Merit Scholarship Programme for High Technology (MSP) for IsDB Member Countries

I. Background

The Merit Scholarship Programme (MSP) was introduced in 1992. It offers scholarships for higher study at renowned high-tech universities and institutions around the world.

II. Objective

The objective of the MSP is to develop technically qualified human resources in IsDB MCs by providing scholarships to promising and outstanding scholars and researchers to undertake advanced studies and research in the fields of applied science and technology needed for the development of the member countries. The main objectives are:

- To develop technically qualified human resources in the MCs;
- To enhance the scientific, technological and research capability and potential of scholars and researchers in MCs;
- To help meet national needs for science and technology; and
- To strengthen the scientific, technological and research capability of institutions in MCs.

III. Concept of the Programme

The concept is to meet the needs of the MCs in science and high technology areas that are crucial to their development by enhancing the scientific, technological and research potential of their scholars/researchers and institutions. The scholars are expected to return to their countries/institutions to apply new know-how for the development of their countries.

IV. Fields of Study

The programme covers studies and research at two levels: (i) three-year or 36 months Ph.D. study; and (ii) 6-12 months Post-Doctoral research. The duration of both Ph.D. study and post-doctoral research are in line with international standards and practice.

Fields of studies and subjects are determined by the direct need and the purpose of meeting the countries' developmental needs related to science and technology. The needs are categorised by the following justifications: (i) lack of expertise; (ii) emerging science; (iii) problem-solving; and (iv) science management.

For general guidance, a broad list of 17 fields of studies is drawn and outlined hereunder. However, as the field of study is chosen from this list, it must gain merit by the relevance and value to the countries' development needs and fall within one of the above four categories.

1. Laser and Fibre Optics
2. Conductors/Semiconductors
3. Polymer Science
4. Genetic Engineering/Biotechnology
5. Nuclear Science/Engineering
6. Electronics/Micro Electronics/Telecommunication.
7. Computer Science (including CAD/CAM)
8. Renewable Energy/Fuel Technology
9. Hydrology/Water Resources
10. Metallurgy
11. Chemical Engineering/Material Sciences
12. Medicine/Pharmaceutical
13. Agriculture/Food Technology
14. System Engineering
15. Space Science/Technology
16. Environmental Preservation Technology
17. Technology Management and Innovation (For post-doctoral research only).

V. Institutions of Study

Priority is given to Ph.D. applicants with secured admission at universities that have concluded a cooperation agreement with IsDB, such as the University of Cambridge; the University of Oxford; the University of Queen Mary; the University of London in the United Kingdom; a number of reputable universities in Malaysia, Turkey and the Makerere University in Uganda.

Successful candidates for the Ph.D. programme may also secure admission at one of the reputable universities in IsDB member countries listed among the top 1,000 in the Times Higher Education Supplement (THES) or QS international universities ranking.

Successful candidates for post-doctoral research are invited to undertake their research project at centres of excellence in IsDB member countries that have facilities and equipment to undertake cutting-edge research projects.

VI. Eligibility requirements

The programme is only for scholars from MCs who are attached to educational, scientific and technological institutions and research centres in their home countries and are actively working in the scientific and technological development of their countries.

The programme does not award scholarships to sole individuals, but to individuals at the institutional level. The institutions are partners in the programme. Promising and talented individuals are sponsored and nominated by their institutions and accepted as appropriate by the offices of IsDB Governors in terms of the developmental and scientific needs of their countries.

To be eligible, applicants for the MSP must meet set criteria, including:

- Be up to the age of: (a) 35 years for Ph.D. study; or (b) 40 years for post-doctoral research;
- Have an M.Sc. (for Ph.D. study) or Ph.D. (for post-doctoral research) in a field of science/technology listed under the programme;
- Have above average ("Very Good") academic achievement;
- Have good command of the language of the institution of study and the ability to conduct scientific work in it;
- Have work and/or research experience of not less than two (2) years for Ph.D. study or five (5) years for post-doctoral research in the related field;
- Have a record of publications/research in the same field;
- Have a proposed field of study and/or research in one of the fields listed under the approved fields of study with scientific and development relevance to the country being clearly demonstrated in a research proposal endorsed by the nominating institution;
- Applicants for post-doctoral research who have had a post-doctoral experience outside their countries within the past two years are not eligible;

Not be an IsDB staff member or Executive Director, his/her alternate, and/or staff of any type of appointment (including temporary and consultant) of the IsDB Group nor a close relative of the aforementioned by blood or adoption, with the term "close relative" defined as mother, father, sister, half-sister, brother, half-brother, son, daughter, aunt, uncle, niece or nephew.

Notes:

The scholarship may only supplement, and shall not duplicate, any other source of financial support the applicant might have. If the applicant is awarded a scholarship, he/she must inform IsDB at that time if he/she has other sources of funding

Sending the application or getting admission by the academic institution does not mean that the applicant has been accepted for a scholarship. Accordingly, the applicant should not take any action concerning his/her current employment or otherwise until notified by IsDB of having been awarded a scholarship.

VII. Benefits and Facilities

For the successful candidates, the scholarship covers the following items:

- **Cost of tuition fees as charged by the universities and payable to the universities directly**
- **Monthly stipend commensurate with the cost of living in the country of study, on a single-status basis**
- **Medical insurance under the university health scheme**
- **Thesis/scientific papers preparation**
- **Conference allowance for Ph.D. scholars**
- **A return air ticket and installation allowance for scholars studying overseas.**

The scholarship does not cover the following:

- **Visa application(s) costs;**
- **Expenses to bring and/or support a scholar's family members**
- **Extracurricular courses or training**
- **Language training not provided by the study programme**
- **Additional travel during your study programme**
- **Expenses related to research, supplementary educational materials, field trips, participation in workshops/seminars, exchange programmes conferences or internships;**
- **Educational equipment, such as computers**
- **Residence permit fee.**

VIII. Obligations of the Beneficiaries

Beneficiaries awarded the scholarship shall:

Sign a surety bond stating their commitment to their studies, to return to their countries upon completion of their studies and to continue work and services to science, technology and development of their countries thereafter for at least twice the period of their studies under the IsDB Merit Scholarship Programme;

Devote themselves to their studies on a full-time basis without interruption and provide IsDB with reports on their academic studies and activities on a regular basis;

Not to seek or accept any other scholarship or remunerated work during their studies under the programme that may interfere with their studies or make the fulfilment of their other obligations difficult, unless otherwise approved in writing by IsDB;

Respect the laws of the country of study and maintain good personal and professional conduct consistent with the rules, regulations and objectives of the programme and the overall mission of the IsDB as an Islamic institution.

IX. Roles of Nominating Institutions

As a partner in the joint effort with IsDB, the institutions nominating candidates for the programme are expected to:

- Duly nominate their candidates, assist them in all aspects of documentation preparation and secure the necessary endorsements from local authorities;
- Assist selected candidates to prepare for departure, place them on study leave and support them in their research;
- Help return scholars resettle and support them in their research and equipment needs.

X. Roles of offices of IsDB Governors

As the channel of announcement, the offices of IsDB Governors are expected to:

- Announce the programme, as widely as possible, among the scientific and research communities in the country;
- Disseminate information to relevant scientific and research institutions and interested scholars in the country;
- Endorse the shortlisted applications in the proposed fields of study that are most needed for the development of the country.
