

SUBJECT: THREE DAYS' TRAINING WORKSHOP ON "E-GOVERNANCE FOR SERVICE DELIVERY". MARCH 04-06, 2024

Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD), an Executive Department of Establishment Division, is responsible for promoting the cause of rural development in Pakistan through its programmes of training and research. Training is imparted, inter alia to officials of the Local Government and Rural Development Departments, elected representatives, functionaries of Nation Building Departments including NGO's in order to improve their professional skills and promote sharing of experiences regarding rural development in Pakistan.

AHKNCRD plans to organize a three days training workshop on "E-Governance for service delivery", from March 04-06, 2024. The major objectives of the training workshop are:

- Learning about the theme of e-governance and its various aspects w.r.t. service delivery,
- Discussing best practices of e-governance from around the developing world,
- Having an overview of policies & initiatives by the Government of Pakistan relevant to e-governance in the country; and,
- Providing a forum for sharing relevant experiences with regard to role of e-governance for ensuring better service delivery in the country.

3. No training fee will be charged for the training; however, TA/DA of the participants shall be borne by the nominating agencies. Boarding and lodging facilities are available in the NCRD Hostel located within NCRD Complex, on the approved rates on double occupancy basis. Food expenses will be borne by the participants and staff is available in the Hostel for necessary services.

4. Participants may please be informed that Family Members/Servants are not allowed to stay with them in the Hostel.
