SUBJECT: - TRAINING COURSE ON “ROBOTIC PROCESS AUTOMATION FOR LEADERS” TO BE CONDUCTED FROM 9TH TO 13TH JUNE, 2024, UNDER THE SINGAPORE-JORDAN ASIA-MIDDLE EASTD IALOGUE (AMED) TRAINING PROGRAMME.

The undersigned is directed to inform that the Government of Singapore has invited Three (03) nominations for the above **Partially Funded** training course from 9th to 13th June, 2024 under the Singapore-Jordan Asia-Middle East Dialogue (AMED) Training Programme. The course is to be held at the AMED Regional Vocational Training Centre in Amman, Jordan. The Governments of Singapore and Jordan will bear the course fees, including trainers' fees, course materials and training venue. The round-trip airfare, accommodation and other local and incidental costs for participants will have to be borne by the nominating Ministry/Division/Provincial Department.

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria.

Applicants should be:

- Be Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials intending to use Robotic Process Automation (RPA) as a solution to improve their agency's work processes;
- Nominated by their respective Governments;
- Proficient in written and spoken English; and
- In good health.
- Prepared to participate Actively in the programme.

Objective.

- Robotic Process Automation RPA has gained traction in the public service as a means to automate high volumes of repetitive and manual work processes. This course will present Singapore's experience in implementing RPA in public agencies and equip participants with foundational skills and knowledge for successful RPA implementation.


3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Division by **5th April, 2024 (Friday)**, positively. Nominees are also requested to apply online at **<https://go.gov.sg/sgjordanrpa2024>**, as required by Singapore (Mandatory). Nominees who have not applied online will not be considered for the training.
