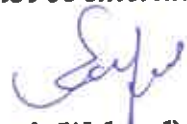

The undersigned is directed to inform that the Government of Singapore has invited one (01) nomination for the above Partially Funded training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), training fees, training allowance and group personal accident/hospitalization insurance. The round-trip airfare for participants will have to be borne by the nominating Ministry or Provincial Department.

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Permanent Government Officers (BS-17 and above) only and nominated by respective Federal Government or Provincial Department.
- Mid- to senior-level government officials who are involved in trade facilitation, economic planning and development work;
- Nominated by their respective governments;
- Proficient in written and spoken English; and
- In good health.

Objective

- This course will provide an overview of economic development through trade facilitation, trade policies, lowering of barriers to trade, and customs modernization.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Division by 11th May 2024 (Wednesday), positively. Nomination without online application will not be considered by the host.
