ON AMENDMENT TO THE REGULATION OF THE MINISTER OF FINANCE

THE MINISTER OF FINANCE OF THE REPUBLIC OF INDONESIA

Considering:

- a. that the provisions concerning the stipulation of import duty on goods in the framework of supporting the implementation of a Preferential Trade Agreement between the Government of the Republic of Indonesia and the Government of the Islamic Republic of Pakistan have been regulated in Regulation of the Minister of Finance Number 29 / PMK.010/2017 concerning Stipulation of Import Duty Rates in the context of Preferential Trade Agreements Between the Government of the Republic of Indonesia and the Government of the Islamic Republic of Pakistan;
- b. that with the ratification of the Protocol to Amend the Preferential Trade Agreement between and the Government of the Republic of Indonesia and the Government of the Islamic Republic of Pakistan through Presidential Regulation Number 114 of 2018 concerning Ratification of the Protocol to Amend the Preferential Trade Agreement between the Government of the Republic of Indonesia and the Government of the Republic of Indonesia and The Government. of The Islamic Republic of Pakistan), it is necessary to make adjustments to the provisions referred to in letter a;
- that based on the considerations as referred to in letter a and letter b, as well as to implement the provisions of Article 13 paragraph (2) of Law Number 10 of 1995 concerning Customs as amended by Act Number 17 of 2006 concerning Amendment to Law Number 10 In 1995 concerning Customs, it is necessary to stipulate a Regulation of the Minister of Finance concerning Amendment to Regulation of the Minister of

DECIDES:

Set : REGULATION OF THE MINISTER OF FINANCE CONCERNING AMENDMENT TO REGULATION OF THE MINISTER OF FINANCE NUMBER 29 / PMK.010 / 2017 CONCERNING DETERMINATION OF TARIFFS OF IMPORT DUTY IN THE TERM OF PREFERENTIAL TRADE AGREEMENT BETWEEN THE GOVERNMENT OF THE REPUBLIC OF INDONESIA AND THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF PAKISTAN.

Article I

Amend the Attachment of the Minister of Finance Regulation Number 29 / PMK.010 / 2017 concerning Stipulation of Import Duty Tariff in the Context of Preferential Trade Agreements between the Government of the Republic of Indonesia and the Government of the Islamic

Republic of Pakistan (State Gazette of the Republic of Indonesia Number 345 2017) so that they are listed in the Annex inseparable from this Ministerial Regulation.

Article II

- (1) The imposition of import duties on imported goods based on import duty rates as meant in Article I, applies to the import of goods whose import customs notification documents have obtained the number and date of registration from the Customs Office of the import port as from the date of entry into force of this Ministerial Regulation.
- (2) This Ministerial Regulation shall come into force after 14 (fourteen) days from the date of promulgation.

In order for everyone to know, order the enactment of this Ministerial Regulation by placing it in the State Gazette of the Republic of Indonesia.
