

2. The eligibility criteria and objectives of the subject courses are as under:

Eligibility Criteria

- Permanent Government Officers (BS-17 and above) nominated by respective Federal Government or Provincial Department with minimum 2 years of experience in the relevant field
- Be under age 40 as on February 1, 2019 (Preferable).
- Have a completed Bachelor Degree or an equivalent to college / university level Educational background
- Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and thesis in English
- Be good health, both physically and mentally, to complete the program.
- Pregnancy is regarded as a disqualifying condition to participate in this program.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Person belonging to the institution in which candidates submitted false documents and returned to his/her country arbitrarily in the middle of SP program cannot apply
- Have not participated in KOICA's scholarship program or any of the Korean government's Scholarship Program earlier (Master's Degree program).

Objectives

To educate decision-makers on climate change policy in developing countries with an emphasis on the following capacities;


- Understanding and integrating mitigation and adaptation policies in response to climate change.
- Identifying and implementing climate change industry in line with the unique demand from developing countries.

- Applying for and receiving global funds from international financial mechanisms for climate change responses to support developing countries.

 - Future career path after completing this program
