

The undersigned is directed to inform that the Korea International Cooperation Agency (KOICA) through Graduate School of Global Cooperation Hallym University, Republic of Korea has invited (04) nominations for the above Fully Funded Master's Degree Program in Response to Climate Change to be held from August 03, 2019 – December 29, 2020 at Chuncheon & Seongnam, Republic of Korea. 2. The eligibility criteria and objectives of the subject courses are as under:

Eligibility Criteria

- Permanent Government Officers (BS-17 and above) nominated by respective Federal Government or Provincial Department with minimum 2 years of experience in the relevant field
- Be under age 40 as on February 1, 2019 (Preferable).
- Have a completed Bachelor Degree or an equivalent to college / university level Educational background
- Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and thesis in English
- Be good health, both physically and mentally, to complete the program.
- Pregnancy is regarded as a disqualifying condition to participate in this program.
- Not be a person who has withdrawn from KOICA's scholarship program.
- Person belonging to the institution in which candidates submitted false documents and returned to his/her country arbitrarily in the middle of SP program cannot apply
- Have not participated in KOICA's scholarship program or any of the Korean government's Scholarship Program earlier (Master's Degree program).

Objectives

To educate decision-makers on climate change policy in developing countries with an emphasis on the following capacities;

- Understanding and integrating mitigation and adaptation policies in response to climate change.
- Identifying and implementing climate change industry in line with the unique demand from developing countries.
- Applying for and receiving global funds from international financial mechanisms for climate change responses to support developing countries.

3. Nomination of suitable candidates, fulfilling the eligibility criteria duly approved by the competent authority along with requisite documents may kindly be forwarded to this Division latest by 9th April, 2019 (Tuesday) positively.

 - Your potential contribution to the field of climate change responses and how Hallym GSGC- -KOICA scholarship program will help you achieve your goals
 - Future career path after completing this program

4. **Two photos, 3×4cm**
5. **Certificate of Degree (or Certificated Expected Graduation Form) of all colleges and graduate schools (should be written in English)**
6. **Official transcripts of all colleges and graduate schools
APOSTILLED or CONSUL VERIFIED**
7. **Two letters of recommendation from professors familiar with the applicant's academic work or from professional supervisors**
8. **Certificate proving English Proficiency:** a score report of a recognized English Proficiency Test such as TOEFL, TEPS, IELTS (if applicable)
9. **Certificate of Employment (if applicable)**
10. **Curriculum Vitae (CV)**
11. Application form **04 Copies**
12. Proforma for Foreign Training **01 Copy**
13. Surety Bonds/ Undertaking **01 Copy**
14. Valid Passport Copy **04 Copies**
15. Copy of National Identity **04 Copies**
