 - c) Company/Firm Website.
 - d) Business Turnover during last two years especially with public sector organization.

 - ii. Proof of on active tax payer list of FBR.

 - iv. Original Affidavit on legal paper that firm/company has not been blacklisted by any Government/Semi Government Organization of Pakistan.
 - v. Earnest money of Rs. 10,000/- (Rupees ten thousands only) in favor of Drawing & Disbursing Officer, Commerce Division, Islamabad in shape of original demand draft or pay order. Personal cheques are unacceptable.

OTHER BIDDING INSTURCTIONS

- i. Technical and financial bids are required to be submitted in separate envelopes. Successful companies in technical bid will be eligible to compete in financial bids. Bids of unsuccessful bidders will be returned.
