#### Geneva, Switzerland

#### 2 to 6 December 2019

The Secretariat of the World Trade Organization and the United Nations Conference on Trade and Development (UNCTAD) are jointly organizing a Thematic Course on Trade in Services Statistics at the WTO in Geneva, from 2 to 6 December 2019.

The course targets services trade statisticians who are directly involved in the collection and/or compilation of trade in services statistics, primarily working in Central Banks, National Statistical Offices or other relevant bodies.

Candidates must possess an excellent ability to communicate in English, both orally and in writing, and demonstrated knowledge and professional experience in the field of trade in services statistics.

At the course, individual sessions will be dedicated to service sectors of trade interest. To this extent, participants will be invited to submit concrete examples of difficulties faced in data collection/compilation in specific services sectors. Possible solutions will then be discussed in the workshop. Participants are expected to be active in sharing their challenges, discussing solutions, and ready to expand their knowledge and develop new skills.

Your government is invited to present one candidate to be considered for participation in this activity.

Participation in the course will be subject to the completion of the WTO-UNCTAD-UNSD e-learning course on trade in services statistics. This integrated approach, combining online learning and faceto-face delivery, maximizes pedagogical quality.

Thirty (30) fellowships are available for applicants. Each fellowship covers a round trip airplane ticket in economy class, Daily Subsistence Allowance, a Terminal Expenses Allowance, and lodging for the duration of the course.
