MINIMUM REQUISITE QUALIFICATION AND EXPERIENCE

i. He/she must have an educational qualification of a Master degree of equivalent in Business Administration, Corporate Finance, Corporate Law, Economics of Chartered Accountant from Pakistan or Foreign Institution of equivalent level recognized by the Higher Education Commission of Pakistan, with at least 12 years' experience out of which 7 years as Key Officer (as defined in Insurance Companies (Sound and Prudent) Management Regulations 2012) in the insurance industry and 5 years management or business experience at senior level

OR

Such persons must (a) be an ACII or FCII (b) Be a fellow of the Institute or Society of Actuaries or equivalent qualification as recognized by the Pakistan Society of Actuaries (c) Hold a Master degree in Insurance, Risk Management or Actuarial Science from a university by the Higher Education Commission, with at least 7 years' experience as Key Officer (as defined in Insurance Companies (Sound and Prudent) Management Regulations, 2012) in insurance industry.

iii. Other eligibilities mentioned in governing rules and regulations including Insurance Companies (Sound and Prudent) Management Regulations, 2012 and Public Sector Companies (Corporate Governance) Rules, 2013 as amended in 2017 and Regulations etc issued by the Federal Government Policy, Regulatory and Financial knowledge of insurance sector will be considered desirable.
