WTO ADVANCED GLOBAL E-WORKSHOP ON THE PLURILATERAL WTO AGREEMENT ON GOVERNMENT PROCUREMENT

7, 10 AND 14 DECEMBER (HALF DAYS)

The Secretariat of the World Trade Organization is organizing the 2020 Advanced Global E-Workshop on the Plurilateral WTO Agreement on Government Procurement (GPA), which seeks to raise awareness of and deepen knowledge about the revised GPA for the benefit of participants from WTO Members and Observers (WT/COMTD/W/248/Rev.1). The online Workshop will be held through a virtual platform over three half-days: 7 December (day 1), 10 December (day 2) and 14 December (day 3).

Purpose and content of the activity

The main purpose of this Advanced Global e-Workshop on the Plurilateral WTO Agreement on Government Procurement is to familiarize participants with the objectives, content and benefits of the revised GPA and related policies like open, non-discriminatory and competitive international government procurement, good governance, and inclusive and sustainable development. Participants will be introduced to the flexibilities provided under the GPA (including in relation to emergency situations like COVID-19), the significance of the GPA in the context of domestic government procurement reform and the promotion of domestic good governance, the benefits of accession to the revised GPA and the possibility to negotiate transitional measures catering for development needs of newly acceding countries.

The programme will consist of presentations by the WTO Secretariat and leading international experts, The presentations will be pre-recorded or shared in "live" format. Owing to differences in time zones, however, it is expected that possibilities for live interaction will be limited. An effort will be made to allow for appropriate deferred interaction between the participants and presenters (Q&As, participant surveys, etc.). A draft programme is attached. The e-Workshop will be held in English only. *

Participation in the activity

The Members and Observers to the WTO, who are eligible to benefit from training and technical cooperation activities, are invited to nominate **up to three senior capital-based officials** to be considered to participate in the above activity. Ideally, at least one official should be from your government's Trade Ministry and at least one from your Ministry of Finance, Procurement Authority or other Ministry or Agency with policy responsibility in this area. **Up to 60 participants** may be selected by the WTO Secretariat to participate in this activity.

Preference will be given to nominees having policy responsibility and/or a demonstrated background in trade and/or government procurement policy matters. The Organisers reserve the right to select candidates and to decline the candidature of nominees who do not most these requirements and/or on the basis of the maximum number of participants.

The WTO Secretariat reserves the right to postpone or cancel this activity in the event of force majeure, or for any reason that render the execution of the activity impracticable for the organizers.

Participants will be required to contribute to the e-workshop by answering survey questionnaires as well as working in groups during the breakout session. Active participation in Q&A sessions is also anticipated and encouraged,

The Application Process
