In pursuance of sub-rule (2) of rule 3 of the Civil Servants (Appointment, Promotion and Transfer) Rules, 1973, the following method, qualifications and other conditions are laid down for appointment to the post-of Translator (R.P.S. 16) in the Ministry of Commerce.

- 2. Method of Recruitment.—The post of Translator will be filled by initial appointment.
- 3. Qualifications, Experience and age-limit for Direct Recruitment.—A candidate must possess the educational qualifications and experience and must be within the age-limit as mentioned against the post concerned in the schedule of this notification.
  - (i) Provided that the maximum age-limit will be relaxed by 3 years in the case of candidates belonging to Scheduled Castes, Buddhist Community, recognized Tribes of the Tribal Areas, Azad Kashmir and Northern

Areas (Districts of Gilgit, Skardu and Diamir) in accordance with the instructions issued by the Establishment Division.

- (ii) Provided further that for Government servants who have completed at least 2 years continuous Government service, maximum age-limit may be relaxed by not more than 10 years up to the age of 55 years whichever is applicable.
- 4. Probation.—Persons appointed by initial appointment shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded or if considered necessary, it may be extended for a period not exceeding one year as may be prescribed at the time of appointment. Appointment on probation shall be subject to the provisions of Section 6 of Civil Servants Act, 1973.
- 5. This Notification issues with the concurrence of the Establishment Division and the Federal Public Service Commission, vide their O.M. No. 1/3/86-R. 3, dated the 4th January, 1987 and letter No. F. 12-55/86-S, dated the 9th April, 1987, respectively.
