YOUTH OF EXCELLENCE SCHEME OF CHINA (YES CHINA)-MASTER-PROGRAM CHINESE GOVERNMENT SCHOLARSHIP

Introduction

To promote the mutual understanding and friendship between China and other countries, and to provide education opportunities to the youth worldwide who have potential in their career, the Chinese Government initiated the "Scholarship for Youth of Excellence Scheme of China-Master Program (YES CHINA)" with the aim of providing financial support for outstanding youth to come to China to pursue a Master's degree. The programs will open to applicants from 82developing countries. For the academic year 2021-2022, the Ministry of Education, P. R. 2. Two-year Program (1+1 studies)

Scholarship for the first academic year is the same as One-year Program. In the second academic year, the students will do their thesis back in their home countries and the dissertation defense in China, while the scholarship will only cover one round-trip ticket for dissertation defense.

Application Receiving Agency and Deadline

The applicants should submit their applications during the application period to the Chinese Embassy in their countries of nationality, or to the 7 program universities. Please contact the Embassies or universities for the specific deadlines for 2021applications.

Qualifications

Qualifications for an eligible applicant include:

Healthy both physically and mentally; not over 45 years old (born after September 1, 1976).

- 2. A bachelor or higher degree, at least 3 years' work experience, some educational or professional experience in a field relative to that of the program applied.
- 2. Working in a government agency, company or research institute, and being a Section Director or Chief of Office, a senior manager, or being a lecturer or assistant researcher or above in scientific researches.
- 4. Good English language proficiency, able to follow English-taught courses well. Minimum requirements for reference: IELTS (Academic)total score 6.0, or TOEFL Internet score 80:
- 5. Having a strong development potential in his/her career, and willing to promote the mutual cooperation and exchanges between China and his/her home country.
- 6. Students who are now studying in China or already winners of Chinese Government Scholarship are not allowed to apply.

Step 2: Documents Submission

Application form (mentioned above) with a 2-inch photo and the applicant's signature.

Personal statement of research (A minimum of 500 words in English).

Copies of bachelor's degree certificate(s) and academic transcript(s).

Two recommendation letters from the applicant's employers and/or professors. Telephone numbers and email addresses of the referees must be included in the letters.

English proficiency certificates.

Physical Examination Record for Foreigner.

Copy of the passport page of personal information (Ordinary Passport for Private Affairs only)

Note: Scanned copies of the documents will be sufficient during the application period. Originals or verified copies will be required upon enrollment at the universities. All documents should be in Chinese or English and are not retrievable.

Admission Notification

- 1. Application documents will be reviewed by Admission Committee, and outstanding applicants will be selected.
- 2. Each applicant will be supported by the scholarship for one program only.
- 3. The universities or the Chinese Embassy will send the Admission Letter and Visa Application Form for Study in China (JW201) to the scholarship winners.
- 4. If a successful applicant fails to register for the programs before the deadline, the entitlement to the scholarship will be cancelled.

- Step 2: Read "Tips for online application" carefully before clicking "NEXT" to the registration page.

- Step 4: Fill in the correct Program Category and Agency Number. An Agency Number represents a specific application receiving agency and a correct choose of Program Category is necessary before filling in the Agency Number. Please make sure you fill it in correctly, otherwise you will not be able to continue your online application or your application will not be accepted.
- Your 'Program Category' is: <u>Type A</u> and 'Agency Number' is: 5861. Once the correct 'Agency Number' is entered, the name of the agency will automatically emerge.
- Step 5: Fill in the Online Application Form and Upload Supporting Documents truly, correctly and completely following the steps listed on the left of the page.
- Applicants are required to select the target university according to Master Program, and discipline is also needed to fill before choosing the major. Please refer to the Disciplines Index, which could be downloaded from Help, if you have any doubt about the disciplines and majors.
- Step 6: Check each part of your Application carefully before submitting it. Click Submit button to submit your Application. The submitted documents will be the only reference for the applied universities to confirm the admission.
- Step 7: You can make changes to your application by clicking Withdraw and Edit the Application on the top of the page. But make sure to click the "submit" button to submit again after finishing all the changes. Otherwise, the retrieved application will become invalid and your new application will not be received by target university.
- Step 8: Download and print the completed Application Form by clicking Print the Application Form.
- Step 9: Send both the soft copy and hard copy of application documents to Chinese Embassy in Islamabad. Soft copy can be sent to islamabad@chinaculture.org.
