Subject: NOMINATIONS FOR THE TRAININGS ON THE MODULE OF E-PROCUREMENTS

E-Governance procurement (e-GP), is considered as the backbone of improving governance through the use of ICT. International experience suggests that technological innovations such as e-Procurement and electronic reverse auction can enhance the efficiency of procurement, eliminate bid rigging, strengthen transparency and achieve value for money (VFM). Digitalization may reduce barriers for participation of SMEs in public contracting, supporting their development and job growth etc.

2. Keeping in view the modern trends of E-Governance procurement (e-GP), the Authority has undertaken to develop a state-of-the-art web based e-Procurement system encompassing the total procurement life cycle starting from planning to closing out of the contract. The system is named as “E-Pak Acquisition & Disposal System” (EPADS) which will be a centralized end-to-end procurement system developed for the whole country including the Federal as well as Provincial Regulatory Authorities (PPRAs making use of the latest technological and communication tools and frameworks.

3. To upgrade the skill set of procurement officers as well as suppliers, procurement professionals, PPRA has designed training modules on different components/aspects of (EPADS) to provide the understanding/ familiarity about the process of e-Procurement. After completion of all requirement of modules, final assessment test of the participants would be conducted and certified accordingly.

4. In view of the above, Public Procurement Regulatory Authority (PPRA) invites the nominations of suitable officers of BPS-17 & equivalent or above working in different Ministries/ Attach Departments/Semi Government/ Autonomous Bodies/ as procurement professionals and will be part of the said department for next two years.

5. It is clarified that no fee would be charged from the nominees. However, other expenditure to be incurred on travelling, boarding and lodging etc of participants will be borne by the nominating organizations.
