

In compliance with the decision of the Federal Cabinet in 2019, I am directed to refer on the above subject and to apprise that updated information of all Government employees is required in order to identify and block all those who were beneficiaries of BISP,

2. In pursuance of the Federal Cabinet and BISP Board decision a policy mechanism was devised to recover public money from govt. in-service employees in all grades and those of Autonomous Bodies/Attached Departments/Semi-Govt/State Owned Enterprises (SOEs) who themselves or their spouses were beneficiaries of BISP.

3. In order to implement the aforementioned policy and to update the BISP database, it is requested to share updated data of in-service employees of the Ministry and employees of all Autonomous Bodies, Attached Departments and State Owned Enterprise (SOEs) under the administrative control of this Ministry on the attached format in soft (Email ID: ad.pg@bisp.gov.pk) and hard form by 10th March, 2023 for further analysis.
