SUBJECT: 2023 MULTILATERAL TRAINING PROGRAMS UNDER CHINA AID

The undersigned is directed to state that Government of People's Republic of China has offered various Multilateral Training Courses / Seminars in different disciplines for the year 2023 for Government of Pakistan (List attached). The Government of Pakistan will not be liable for any cost. The requisite qualification and general requirements are as under (copy enclosed):-

1. Eligibility Criteria

- Officers (BS-17 & above) of Ministries / Divisions / Attached Departments and Provincial Governments most relevant to the training programmes.
- Proficiency in English.
- Contract Employees are not eligible

2. Documents Required

The following documents (02 sets of each) are required to be sent alongwith the nomination:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Copy of CNIC
- Copy of Passport at least six months of remaining validity and blank visa pages
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking
- Copy of Covid-19 Full Vaccination Certificate
- For candidates using ordinary passport, No criminal record certificate attested by Ministry of Foreign Affairs of Pakistan will be needed.

3. Relevant Ministries / Divisions / Attached Departments and Provincial P & D Departments must note the following points while nominating the candidates:

- a. Most relevant candidates should be nominated for the subject training programmes.
- b. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the EADs' deadline will not be entertained.
- c. Nomination papers complete in all respect may be forwarded to MoEA through proper channel i.e. through their respective Administrative Ministry / Division/ P&D Department.
