





Subject: **SUSPENSION OF IMPORT CONDITONS CONTAINED IN IMPORT POLICY ORDER 2022 WITH REGARD TO IMPORT OF TIMBER/WOOD**

In continuation of this Ministry's O.M. of even number dated 26<sup>th</sup> June, 2023 on the subject cited above, it is clarified that operation of Import Policy provisions contained in Sr. No. 386 to 440 of Part IV, Appendix-B, Import Policy Order 2022, i.e. import conditions with regard to import of Timber/Wood have been suspended from the date of issuance of Import Policy Order, 2022 till 31<sup>st</sup> October, 2023 i.e. for the Bills of Lading issued till 31<sup>st</sup> October, 2023.


