  - Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the EADs' deadline will not be entertained.

Inner Mongolia Agricultural University (IMAU) is a multi-disciplinary university with a focus on agriculture and forestry, characterized by grassland animal husbandry, and eight disciplines including agriculture, engineering, science, economics, management, humanities, law, and arts. It has a complete higher education system for cultivating vocational colleges. bachelor's, master's, and doctoral students. In 2001, it became a key university supported by the "One Province, One University" in the national western development. In 2012, it became a "provincial and ministerial co construction" university jointly established by the State Forestry Administration (now the State Forestry and Grassland Administration) and the People's Government of the autonomous region. In 2013, it entered the ranks of supporting universities

in the national "Central and Western Higher Education Revitalization Plan".

Inner Mongolia Agricultural University is the earliest university in Inner Mongolia to carry out education for foreign students and exchange of visiting scholars. It has established intercollegiate cooperation and academic exchange relationships with more than 70 universities and research institutions from more than 20 countries, including the United Kingdom, the United States, Canada, Australia, Russia, Japan, and Mongolia, and has rich experience in training and managing international students and technical personnel. The teaching infrastructure, teaching equipment, textbooks, teachers, laboratories, internship bases, and other teaching conditions for international students and foreign technical personnel training are complete. There are specialized foreign experts and student buildings provided for international students, and the accommodation environment and medical system are very perfect. More than 700 experts and professors from abroad have come to the university for academic exchange, visiting lectures, scientific research cooperation, and other activities. The school has set up the "the Belt and Road" Research Institute, and participated in the "the Belt and Road" education foreign aid projects, academic exchanges and scientific research cooperation.

In 2012, the school became the designated institution for China-nided training programs held by the Ministry of Commerce and is also the only university in Inner Mongolia Autonomous Region to undertake such projects. It has organized 35 sessions of multilateral and bilateral China-aided training and trained a total of 938 participants from 60 countries. In addition, it has been selected to participate in the "Chinese Intangible Cultural Heritage Inheritance Practitioners Training Program" jointly organized by the Ministry of Culture and the Ministry of Education. - (2) Visit Yide Experimental Factory for yogurt and ice cream processing;
- (3) Visit Changhong Dairy Factory for the industrial production of traditional dairy products;

- (5), Visit Palace, Museum, the Great Wall, Inner Mongolia Museum;
