#### OFFICE MEMORANDUM

## SUBJECT: 2023 MULTILATERAL TRAINING PROGRAMS UNDER CHINA AID (OCTOBER – DECEMBER) (SECOND BATCH)

The undersigned is directed to state that Government of People's Republic of China has offered fully funded Multilateral Training Courses / Seminars in different disciplines for the year 2023 for officers of Government of Pakistan (List attached). The Government of Pakistan will not bear any cost. The requisite qualification and general requirements are as under:-

#### 1. Eligibility Criteria

- Officers (BS-17 & above) of Ministries / Divisions / Attached Departments and Provincial Governments most relevant to the training programmes.
- Contract Employees are not eligible.
- Employees on probation are also not eligible.
- Age limit: 45 years for BPS 17-19 and 50 years for BPS 20-22.

#### 2. Documents Required

The following documents (02 sets of each) are required to be sent alongwith the nomination:

- Application Form
- Information Form duly filled in by the nominee.
- FTC Proforma.
- Copy of CNIC
- Copy of Passport with at least six months of validity and blank visa pages
- Medical Certificate (Foreigner Physical Examination Form)
- Surety Bond
- Undertaking
- Copy of Covid-19 Full Vaccination Certificate
- For candidates having ordinary passport, Police Character certificate attested by Ministry of Foreign Affairs of Pakistan will be needed.

- 3. Relevant Ministries / Divisions / Attached Departments and Provincial P & D Departments must note the following points while nominating the candidates:
  - a. Most relevant candidates should be nominated for the subject training programmes.
  - b. Nomination of candidates should reach MoEA before the deadline.
  - c. Nomination papers shall be forwarded to MoEA through proper channel i.e. through respective Administrative Ministry / Division/ P&D Department.
