Fee payment receipt in both cases either cash deposit in bank or online payment should be attached with APO Biodata Form (bank details are available at NPO website). Moreover, selected participants from public and private sector will shoulder the cost of visa fee, insurance, PCR testing, accommodation for early arrival/late departure and airport taxes, etc.
- APO will meet airfare, boarding lodging, per diem of participants from Government departments and SME Sector for participation in APO programs.
