Akhtar Hameed Khan National Centre for Rural Development (AHKNCRD), an Executive Department of Establishment Division, is responsible for promoting the cause of rural development in Pakistan through its programmes of training and research. Food arrangements will be made by the participants on self-finance basis for which staff is available in the Hostel.
