The undersigned is directed to refer to this Ministry's letter of even number dated October 17, 2024 on the above subject and to inform that the Government of Singapore has invited nominations for the above Partially Funded training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), course fees, training allowance and group personal accident/hospitalization insurance. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in TVET;
- Nominated by their respective governments;
- Proficient in written and spoken English; and
- In good health..

Objective:-

- This course will challenge participants to rethink reform and digitalise their existing Technical and Vocational Education and Training (TVET) systems to contribute to economic and social development.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by 20th December, 2024 positively. Interested officers are requested to apply online at <https://go.gov.sg/scpta-sst4> required by Singapore (Mandatory). Nomination without online application will not be considered by the host.
