<u>Capacity Building Program on Islamic Finance for Government Officials</u> (December 18 - 19, 2024 at NIBAF, Islamabad)

The Federal Shariat Court (FSC) announced its judgement with respect to 'Riba Case' on April 28, 2022, wherein, inter alia, the FSC disposed-off matters relating to Riba/Interest and also gave specific time bound directions for legislative amendments and complete elimination of Riba from the economy. In this connection, the Federal Government has constituted a 'Steering Committee for Providing Strategic Guidance Regarding Implementation of FSCs Judgement on Riba' under the patronage of Minister for Finance & Revenue and chairmanship of the Governor, State Bank of Pakistan (SBP).

- 2. Under the guidance received from the aforementioned Steering Committee, various working groups on different areas have been formed. Among them, the Working Group on Awareness Creation & Capacity Building is undertaking multiple measures for providing training opportunities on Islamic finance to relevant stakeholders including government officials. In this context, a capacity building program has been scheduled on December 18 19, 2024 at NIBAF, Islamabad.
- Since Islamic finance is fast emerging as a prudent financial discipline and is also very much relevant different government departments, therefore Ministry of Commerce and Textile Industry is invited to ominate their staff for the subject capacity building program to be held during December 18 19, 2024 at INBAF, Islamabad. It is further mentioned that there is no participation fee, as the program is sponsored by the SBP.
