WTO ADVANCED GLOBAL WORKSHOP ON THE AGREEMENT ON GOVERNMENT PROCUREMENT (GPA) 2012

28 APRIL - 2 MAY 2025

The Secretariat of the World Trade Organization (WTO) is organizing the **WTO Advanced Global Workshop on the Agreement on Government Procurement (GPA) 2012** for the benefit of participants from eligible WTO Members and observers (WT/COMTD/W/273 and Corr. 1). The Workshop will take place from **28 April** to **2 May 2025 in Geneva**.

Purpose and content of the activity

The purpose of the Workshop is to **build participants' knowledge and skills, and share perspectives, relating to the interface of government procurement, international trade, development and good governance, with a specific focus on the GPA 2012**.

More specifically, the Workshop aims to familiarize participants with the GPA 2012 and related recent developments, the WTO Committee on Government Procurement, and the synergies and complementarities between the GPA 2012 and other international instruments and free trade agreements. The Workshop will also provide an opportunity to reflect upon the potential benefits and challenges of accession to the GPA 2012, the flexibilities available to developing countries seeking accession, the accession procedure, and the observer status in the Committee. Aspects relating to the implementation of the GPA 2012, including sustainable procurement, SME participation in government procurement markets, the prevention of corrupt practices, domestic review procedures, and e-procurement, will also be addressed.

The programme will comprise presentations by the WTO Secretariat and other international experts. A draft programme is attached. The Workshop will be held in the three official languages of the WTO, with the delivery of presentations in **English** and simultaneous interpretation into **French and Spanish**. Comprehension of the candidates' preferred WTO language might be checked orally.

Participation in the activity

The Governments of Members and observers to the WTO, who are eligible to benefit from training and technical cooperation activities, are invited to nominate **up to three senior capital-based government officials** to be considered to participate in the above activity. Ideally, nominations should include officials from your government's Trade Ministry and from your Ministry of Finance, Procurement Authority or other Ministry or Agency with policy responsibility in the area of government procurement. **The maximum total number of participants for this activity is 30 and all selected participants will be funded.**

Preference will be given to nominees having policy responsibility and/or a demonstrated background in trade and/or government procurement policy matters. Successful completion of the WTO e-learning course on the objectives, rules and operation of the GPA 2012¹ would be an asset. The organizers reserve the right to select candidates and to decline the candidature of nominees who do not meet these requirements.

A round trip airplane ticket in economy class, accommodation for the duration of the course, a daily subsistence allowance and a terminal expenses allowance will be provided to funded candidates. Further administrative details will be communicated directly to the selected participants.

Participants will be required to contribute to the Workshop by providing comments on their national experiences and actively participating in the group exercises and should come duly prepared.

Application process

The application process consists of the following steps:

The online application form requires uploading a scanned copy of the passport and of the official nomination letter, signed and stamped by the competent government authority that is nominating the candidate. A template for such a letter to be signed and stamped by the national authority can be found in Annex 1 to this Invitation letter.
- 3. The application form, including the passport and nomination letter, should be submitted via the online application system **NO LATER THAN 3 MARCH 2025.**
- Applications are to be validated by the Embassy/Permanent Mission to the WTO. Validations should be addressed by email to the WTO Institute for Training and Technical Cooperation (Email: <u>logistics.unit@wto.org</u>) NO LATER THAN 3 MARCH 2025.

The WTO Secretariat reserves the right to postpone or cancel this activity in the event of force majeure, or for any reason that render the execution of the activity impracticable for the organizers.
