The undersigned is directed to inform that the Government of Singapore in collaboration with Government of Qatar has invited nominations for the above <u>Partially Funded</u> training course at Doha, Qatar. The Governments of Singapore and Qatar will bear course fees, including trainers' fees, course materials, and training venue. However, the cost of round-trip airfare, accommodation, and other local and incidental costs for the participants would be borne by the nominating agency/nominee himself/herself and as insurance will not be provided, participants are strongly advised to purchase comprehensive travel insurance which includes medical evacuation in the event of any unexpected emergencies. 2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria:-

- Be Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
- Mid-to-senior level government officials from AMED members who are involved in policymaking and public service delivery.
- Proficient in written and spoken English.
- In good health.
- Prepared to participate actively in the programme.

Objective:-

- This course will share Singapore's experience in public sector leadership, economic development, good governance strategies and human capital development.
- 3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by 30th April, 2025 positively. Interested officers are requested to apply online at https://go.gov.sg/sgqatarslpg2025 as required by Singapore (Mandatory). Nomination without online application will not be considered by the host.
