The undersigned is directed to inform that the Government of Singapore has invited nominations for the above <u>Partially Funded</u> training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), course fees, training allowance and group personal accident/hospitalization insurance. The cost of round-trip airfare for the participants would be borne by the nominating agency/nominee himself/herself. - 2. The eligibility criteria and objectives of the subject course are as under: **Eligibility Criteria:-**
- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in policymaking for promoting the use of IP systems;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will share Singapore's insights on the commercialisation and financing of intellectual properties (IP) and other intangible assets, which are regularly created but also routinely underperforming in commercialisation. The course will also cover the rules of IP protection and commercialisation, and how government policies and offices can promote the commercial utilisation of these assets.
- 3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by 26th May, 2025 positively. Interested officers are requested to apply online at https://go.gov.sg/IPcommercial as required by Singapore (Mandatory). Nomination without online application will not be considered by the host.

- 6. Further, it may be apprised that as per direction of Foreign Training Committee (FTC) of Ministry of Economic Affairs, all officers proceeding on foreign trainings have been directed to submit a 1000-word post-visit report upon return. Accordingly, the
