## OFFICE MEMORANDUM

#### SUBJECT: 2025 MOFCOM SCHOLARSHIPS-CSC PROGRAM (10 SLOTS)

The undersigned is directed to state that the Government of the People's Republic of China has offered seats for 10 qualified candidates in 2025 MOFCOM Scholarships-CSC Program. The Chinese side has further informed that the candidates cannot be withdrawn once nominated and the final application result will be subject to the MOFCOM and the University. The 2025 MOFCOM Scholarships-CSC Program Enrollment Guide and List of Universities for MOFCOM Scholarship-CSC Program can be downloaded from EAD's website: www.ead.gov.pk. The Programs will not involve any expenditure (TA/DA) on the part of Government of Pakistan. The requisite general requirements are as under:

### **General Eligibility Criteria**

- Officers (BS-17 & above) of Ministries / Divisions/ Departments and Provincial Governments most relevant to the programmes.
- Age 45 years (born after September 1, 1980).
- Three years working experience, and be a bachelor degree holder when applying for master's program; be a master's degree holder when applying for doctoral program;
- Be sufficient in English which meets the academic requirements of the program, be equivalent to IELTS 6.0 and TOFL 80 and above level;
- **Contract Employees are not eligible**
- Female applicants should be more than 30%

#### **Documents Required**

The following documents (02 sets of each) are required to be sent along with the nominations to this Ministry:

- Application Form with Participant signature and Photo
- Latest FTC Proforma downloaded from website
- Copy of CNIC
- Foreigner Physical Examination Form with Photo
- Surety Bond
- Undertaking
- Full sets of application documents (Annex-I)
- Nominations of suitable candidates fulfilling the eligibility criteria duly approved by the competent authority may be forwarded to this Division by 19<sup>th</sup> May, 2025 positively. All Ministries / Divisions and Provincial P&D Departments must note the following points while nominating the candidates:
  - Most relevant candidates should be nominated for Scholarship programmes. 1
  - 2. Nomination of candidates should reach MoEA before the deadline. Late arrival of nomination after the MoEAs' deadline will not be entertained.
