1. Be permanent Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
2. Preferably) Under the age of 40
3. Citizen of a partner country, officially recommended by the country's government.
4. Holder of a Bachelor's degree from a recognized institution.
5. Must meet the university's selection criteria.

KOICA Doctoral Degrees

1. Those meeting the above selection criteria for a Master's degree
2. A Master's degree holder of KOICA's Scholarship Programs
3. Applicants who have passed the local interview for the "2025-1 KOICA Scholarship Program" are not eligible to apply for the "2025-2 KOICA Scholarship Program"
