OFFICE MEMORANDUM

SUBJECT: KNOWLEDGE SHARING ON CRITICAL MINERALS TO MANUFACTURING VALUE CHAINS REPUBLIC OF KOREA, 22-26 SEPTEMBER 2025

The undersigned is directed to refer ADB's self explanatory letter dated 16th July, 2025 on the above subject. ADB is organizing the **Knowledge Sharing on Critical Minerals to Manufacturing Value Chains**, with the Korea Development Institute (KDI). The Knowledge Sharing Event will be held on **22-26 September 2025 in Republic of Korea**. The tentative program is attached.

2. The objective of the event is to provide participants with comprehensive understanding of (i) industrial policies related to critical minerals and their integration into manufacturing value chains; (ii) investment and corporate strategies from upstream (exploration), midstream (refining and processing), downstream (manufacturing sectors such as electric vehicles and batteries), and recycling; and (iii) public and private financing mechanisms to support critical mineral development, recycling infrastructure, and value chain upgrading.

3. ADB has requested for total **three (03)** senior level officers, one each from Ministry of Industries and Production, Ministry of Commerce and Ministry of Energy (Petroleum Division). ADB will cover the cost the participation of the delegation, which will include roundtrip airfare (Economy class), hotel accommodation, daily subsistence allowance, and lumpsum miscellaneous travel allowance. **Visa, if required, will be the responsibility of the participant.**

4. The Ministry of Industries and Production, Ministry of Commerce and Ministry of Energy (Petroleum Division) are requested to nominate one senior officer each from their respective relevant wings. Furthermore, the nominated candidates are requested to completely fill the EAD-ADB nomination proforma and submit a Post Visit report to EAD. This is mandatory requirement for consideration of nomination. Submission of Post Visit Report is also a mandatory requirement for seeking nominations for ADB future courses. No nomination will be entertained without Nomination Performa. The nominations along with designations and complete contact information (postal address, email address, telephone numbers and CV) with a copy of the participant's valid passport's photo page please be shared to this Division by **27th July, 2025**.
