The undersigned is directed to inform that the Government of Singapore has invited nominations for the above <u>Partially Funded</u> training course. The Government of Singapore will bear local hospitality (accommodation and local transfers), course fees, training allowance and group personal accident/hospitalization insurance. The cost of round-trip airfare for the participants would be borne by the nominating agency/nominee himself/herself. #### Eligibility Criteria:-

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in urban planning, infrastructure projects planning and investments;
- Proficient in written and spoken English;
- In good health.

### Objective:-

- This course will explore the principles of urban planning, with a focus on sustainable development and integrated planning approaches. Drawing from Singapore's experiences, participants will examine policy frameworks, planning strategies, and innovations in creating sustainable and resilient urban environments.
