OFFICE MEMORANDUM

SUBJECT: TIMELY INTIMATION OF REQUESTS FOR DEFERMENT FROM FINAL PASSING OUT EXAMINATION

The undersigned is directed to enclose Federal Public Service Commission's letter dated 4th June, 2025 on the subject and to state that deferment from Final Passing Out Program (FPOE) is granted to the probationers of all Occupational Groups and Services by this Division under Rule 10 of the Occupational Groups & Services (Final Passing Out Examination) Rules, 2003 which provides that: -

"a probationer unable to appear at the examination due to any reason whatsoever shall take prior permission from the government and submit a copy thereof to the Commission before commencement of examination".

2. It has been observed that some Ministries/ Divisions/ Cadre Administrators forward requests of deferment from FPOE by the probationary officers, casually even after the conduct of examination, which is not in line with Rule 10 reproduced above. Further, these officers are considered absent from examination and treated as failed in FPOE exam in the light of Rule 6(3) of the Occupational Groups, Services (Probation, Training & Seniority) Rules, 1990. Further, their appointment is liable to termination without notice in the light of Rule 3(1) of the ibid Rules.

3. Foregoing in view, all the Cadre Administrators are, requested to kindly take note of the above and in the future, forward requests of probationary officers for deferment from FPOE almost 15 days prior to the conduct of examination, so that such requests could be processed timely.
