SUBJECT: <u>SEMINAR FOR YOUNG DIPLOMATS FROM THE ISLAMIC REPUBLIC OF PAKISTAN</u> <u>FROM 11TH TO 20TH NOVEMBER, 2025 (20 SLOTS)</u>

The undersigned is directed to state that the Government of the People's Republic of China has offered the subject bilateral seminar for officers of the Government of Pakistan (**Details attached**). The Chinese side has further informed that the candidates **cannot be withdrawn once nominated**. The Government of Pakistan will not be liable to bear any cost. The requisite general requirements are as under:

Eligibility Criteria

- Officers (BS-17 & above), most relevant to the training programme.
- Proficiency in English.
- Under 45 for officials at or under director's level; Under 50 for officials at director general's level.
- Contract Employees are not eligible.

Documents Required

The following documents are required to be sent along with the nomination:

- Application Form with personal signature and photo (**Original & Copy**).
- Information Form with personal signature and photo (Original & Copy).
- Copy of Passport with at least six months of remaining validity and blank visa pages.
- Foreign Physical Examination Form with personal photo (Original & Copy).
- No criminal record certificate or Police Clearance Certificate, attested by the Ministry of Foreign Affairs of Pakistan, if not visited China within the last 5 years.
- FTC Proforma
- Copy of CNIC
- Surety Bond on stamp paper (Original)
- Undertaking on stamp paper (Original)
- No Objection Certificate (Provide within two days after selection)
- 2. The nominations of suitable candidates, fulfilling the eligibility criteria, duly approved by the

competent authority may be forwarded to this Ministry by 21st October, 2025 positively. All Ministries / Divisions / Attached Departments and Provincial P & D Departments must note the following points while nominating the candidates:

- 1. Most relevant candidates should be nominated for the Training course.
- 2. Nomination of candidates should reach EAD before the deadline. Late arrival of nomination after EAD's deadline will not be entertained.
- Nomination papers, complete in all respects, must be forwarded to EAD through 3. proper channel i.e. through the respective Administrative Ministry / Division/ P&D Department.
- All candidates must follow the code of conduct (Annex-I). 4.
- 5. For further details / information proforma EAD's forms / FTC website: www.ead.gov.pk may be visited.
- In order to avail the training program, it may be ensured that suitable nominations, 3. along with their complete documents, are provided to this Ministry before the closing date.
