**SUBJECT: TARIFF RELATED BUDGET PROPOSALS FOR THE FISCAL YEAR 2026-27**

2. It is suggested that while formulating the proposals, provision of the existing Customs Tariff rates may carefully be studied/consulted. Wherever required, the proposal may be supported with the statistical data, etc., so that it is not dropped on account of any such infirmity. The principles, objectives and targets of the National Tariff Policy 2025-30 (NTP 2025-30) may also be kept in view while forwarding the proposals for the budget.

3. In case of local manufacturers claiming tariff protection on its finished product(s) or concession on its raw materials, complete data as per the given format may be provided.

4. Keeping in view the above, it is requested that the budget proposals may be sent to this ministry by 30<sup>th</sup> January, 2026 positively through e-mail mocbudgetexercisefy2026.27@gmail.com followed by the hard copies. It may be noted that proposals submitted after the deadline will not be entertained.
