**Eligibility Criteria:-**

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials who are involved in food safety policies;
- Proficient in written and spoken English; and
- In good health.

**Objective:-**

- This course will share Singapore's national strategies and policies in ensuring safe food supply. It will also focus on frameworks, laws and regulations that are science- and risk-based.

Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **13<sup>th</sup> February, 2026** positively. 
