Eligibility Criteria:-

- Be permanent government employee (BS-17 or above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in practitioner and policy roles in urban development and/or heading smart city developments;
- Proficient in written and spoken English; and
- In good health.

Objective:-

- This course will equip participants with the knowledge and skills required to drive progress at urban level against the backdrop of climate impacts, changing economies, ecological and social systems to build a resilient and sustainable city.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by **30th January, 2026** positively.
