

2. The eligibility criteria and objectives of the subject course are as under:

Eligibility Criteria

- Be Government employees (BS-17 and above) nominated by the respective Federal Ministry or Provincial Department.
- Mid- to senior-level government officials involved in policymaking for sustainability and clean energy solutions;
- Proficient in written and spoken English; and
- In good health.

Objective

- This course seeks to provide an overview of renewable and low carbon energy technologies, with a focus on the use of hydrogen and waste-derived renewable fuels as green fuels. Participants will also learn more about Singapore and Japan's approaches towards research and adoption of green fuels.

3. Nomination of suitable candidates duly approved by the competent authority along with the following documents may kindly be forwarded to this Ministry latest by March 16, 2026 positively.
