Subject: - **ADMISSION IN 1ST YEAR MBBS AGAINST 07 SEATS IN FATIMA JINNAH MEDICAL COLLEGE, LAHORE RESERVED FOR THE REAL DAUGHTERS OF FEDERAL GOVERNMENT SERVING CIVIL SERVANT FOR SESSION 2015-16**

The undersigned is directed to state that applications for seven reserved seats (four for BS-1 to BS-15 and above) are invited from the real daughters of the Federal Government Serving Civil Servants (as defined in Rules of Business, 1973 and its Schedules I & III and fulfill the definition of Civil Servants as defined in the Civil Servants Act, 1973, for admission in 1st Year MBBS in Fatima Jinnah Medical College, Lahore for **Academic Session 2015-16**.

2. Federal Government Serving Civil Servants, who desire their real daughters to be considered for admission in 1st Year MBBS in Fatima Jinnah Medical College, Lahore against the seven reserved seats, should route their applications on prescribed Application Form, duly completed by the applicants through their respective Ministry / Division. Applications duly certified by the competent authority alongwith following attested documents of the applicants must reach to National Testing Service I-E, Street No.46, Sector I-8/2, Islamabad, at the earliest but not later than 7th December, 2015.

S. No. Documents required

1. Matriculation Certificate and Detailed Marks Sheet.
2. F.Sc. Certificate and Detailed Marks Sheet
3. Two self-addressed envelopes
4. Admit Card to Entry Test / Entry Test Result Card for provincial open merit seats
5. Two passport size photographs
6. Attested copy of salary pay slip of parent issued from the AGPR
7. A COPY OF THE Entry Test result is required to be attached with the application and in case the entry test results have not been announced at the time of submitting application for the subject seats, a copy of the Admit Card to Entry Test may be attached with the Application Form. If the Entry Test is not conducted in the province, then candidate is required to submit an affidavit that she will submit the result as ~~an~~ when test is conducted.

The following conditions apply: -

- a) Adopted daughters of the Federal Government Serving Civil Servants not eligible for the reserved seats.
 - b) Either of the parent is a Federal government serving civil servants and the applicant is his / her real daughter.
 - c) In case of selection against open merit in MBBS seats, in the province the applicants is required to inform the Cabinet Division immediately so that her candidature for the reserved seat for Fatima Jinnah Medical College, Lahore be removed from the list of candidates. In case a candidate hides her selection on open merit, her admission shall be liable to the cancelled in FJMC at any stage of her studies if so discovered.
4. The final authority in the selection and nomination for these 07 reserved seats is the Secretary, Cabinet Division and no petition whatsoever will be entertained on this account.
5. NTS will hold Entry Test on 27th December, 2015. Last date for receiving applications by NTS is 7th December, 2015. Applications received after closing date or incomplete applications will not be entertained.
6. The Application Form is enclosed herewith. However, it can also be downloaded from the websites of Cabinet Division (www.cabinet.gov.pk) and NTS www.nts.org.pk.
7. All Ministries / Division / Departments are requested to widely disseminate the above information amongst all Civil Servants, and provide the attached Applications Form to the eligible candidates.

Note:

1. The daughters of employees of Autonomous Bodies / Semi Autonomous Bodies / Corporations and Armed Forces Departments / Organizations, **not included** in Scheduled I & III of the Rules of Business, 1973, and **do not** fulfill the definition of Civil Servants as defined in the Civil Servants Act, 1973, are not eligible for admission against these seats.
