
Subject: - Workshop on WTO/ ESCAP Advanced Government Procurement for Asian Economies from 1-3 November, 2011 at Bangkok.

The undersigned is directed to refer to Embassy of Pakistan's letter dated 8th September, 2011 and to say that United Nations Economic and Social Commission for Asia and the Pacific (UNESCAP) is organizing a Workshop on "WTO / ESCAP Advance Government Procurement for Asian Economies" scheduled to be held from 1-3 November, 2011 at Bangkok (copy along with its enclosures is enclosed).

This workshop aims to provide participants with enhanced awareness of the concepts, principles and obligations of the WTO Agreement on Government Procurement, and the modalities and benefits of accession to the Agreement including flexibilities available to development countries. This workshop will also provide a forum for discussion on the potential role the Agreement can play as a global standard with regard to the promotion of trade, governance and value for money objectives in the government procurement sector. 
