
2. Embassy of People's Republic of China has informed that in order to enhance the exchange and cooperation between China and other developing countries in the field of International Sustainable Development and Humanitarian Relief Cooperation, Ministry of Commerce of the People's Republic of China will hold a **Ministerial Workshop on International Sustainable Development and Humanitarian Relief Cooperation Forum and Capacity Building Workshop From August 31<sup>st</sup> To September 8<sup>th</sup>, 2013**. They have invited one vice-ministerial level official to participate in the subject seminar who could be accompanied by one assistant. Copy of the Note Verbal of Chinese Embassy is enclosed.

3. Further clarification by the Chinese Embassy provided that such Ministerial level Workshops are generally represented by one vice Minister level official equivalent to BS-21 officer of GOP and only a Minister could be accompanied by one assistant of BS-17/18.

4. The expenses of the participants including air fare, accommodation and site visits, in China, will be covered by the Chinese government.
