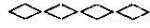

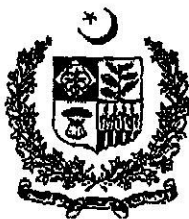


2. The Government of Singapore will bear the round-trip economy airfares, local hospitality (local transfers and accommodation), training fees, training allowance and hospitalization insurance.

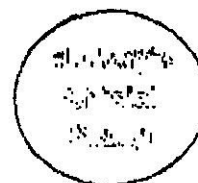
