Singapore Cooperation Programme

Singapore has provided technical assistance to other developing countries since the 1960s. As a country whose only resource is its people. Singapore believes that human resource development is vital for economic and social progress. Singapore itself has benefited from training provided by other countries and international organisations. Through the Singapore Cooperation Programme (SCP), Singapore can contribute to the development of other developing countries.

In 1992, the SCP was established, bringing together under one framework the various technical assistance programmes offered by Singapore. Through the SCP, the range and number of training programmes have been increased to meet the needs of developing countries, Since 1992, Singapore has sponsored training courses and study visits for over 75,000 officials from 170 countries. The SCP is managed by the Technical Cooperation Directorate of the Singapore Ministry of Foreign Affairs.

World Trade Organization

The World Trade Organization (WTO)'s overriding objective is to help trade flow smoothly, freely, fairly and predictably. It does this by:

- Administering trade agreements
- Acting as a forum for trade negotiations
- Settling trade disputes
- Reviewing national trade policies
- Assisting developing countries in trade policy issues, through technical assistance and training programmes
- Cooperating with other international organisations

The WTO has over 150 members, accounting for over 97% of world trade. Around 30 others are negotiating membership. Decisions are made by the entire membership.

The WTO's top level decision-making body is the Ministerial Conference. Below this is the General Council (normally ambassadors and heads of delegation in Geneva, but sometimes involving officials sent from members' capitals) which meets several times a year in the Geneva headquarters. The General Council also meets as the Trade Policy Review Body and the Dispute Settlement Body.

At the next level, the Goods Council, Services Council and Intellectual Property (TRIPS) Council report to the General Council. Numerous specialised committees, working groups and working parties deal with the individual agreements and other areas such as the environment, development, membership applications and regional trade agreements.

Workshop Objectives and Outline

The advanced workshop will have as main themes the in-depth treatment of: policy and regulatory issues in services trade and, in this context, of the relevance of the GATS and its provisions in governing the scheduling of commitments; the state of play in the negotiations, including in rule-making areas such as domestic regulation; features and content of regional and other preferential agreements on services trade, and their treatment under the GATS; and the treatment of financial services under the GATS.

The themes will be treated through presentations, but also practical exercises and discussions with participants. The programme also foresees a negotiation simulation designed to enhance the capacity of participants to work with schedules of commitments. A detailed programme will be distributed prior to the event.

The workshop is targeted at professionals with experience, at advanced level, on services trade, Participants are expected to come prepared to engage in active learning, which may include making presentations and taking part in discussions on the relevant challenges faced by their respective government.

Duration

The workshop will be held from 27 February to 1 March 2012.

Each invited member and observer economy will be represented by one (1) capital-based official from the trade ог other relevant Ministry/Department with responsibility matters relating to policy-making and negotiations on trade in services. As this is an advanced course, participants with sufficient knowledge of services trade will be able to benefit from their participation in this event.

Participants should possess a firm understanding of the GATS, as evidenced by their successful completion of the WTO e-training module on the GATS or equivalent (e.g., relevant experience on services negotiations, WTO regional trade policy course). Participants will also be required to read certain material sent by WTO Secretariat officials before the start of the workshop.

Applicants applying for sponsorship under the Singapore Cooperation Programme should also be:

- Middle to senior level government officials
- Nominated by their respective Governments
- Proficient in spoken and written English
- Below 50 years of age
- In good health

Terms of Award

(Applies ONLY to Member and Observer Economies sponsored by the Singapore Government)

The workshop is sponsored by the Singapore Government under the Singapore - World Trade Organization Third Country Training Programme.

Under this programme arrangement, the Government of Singapore will bear the following

expenses for the successful applicants, thereafter, known as participants during their training in Singapore. These expenses include:

- Economy class round-trip air tickets between Singapore Changi International Airport and the respective airports designated by the Singapore Ministry of Foreign Affairs
- A daily training allowance of Thirty Singapore Dollars (SGD30) from first day to last day of the workshop to cover meals and daily expenses. (Complimentary breakfast is provided in the hotel from the first day to one day after the workshop.) Lunch will be provided during the days when lessons are conducted. A proportionate reduction in the daily training allowance will be made if you are unable to attend the full duration of the workshop. You may wish to bring with you additional funds to cover your expenses in Singapore
- Medical insurance for participants to cover accident and hospitalisation during their stay in Singapore in accordance with the policy of a local insurance company and
- Accommodation for the entire duration of the workshop

Note:

- (i) Participants are to bear their personal miscellaneous expenses that might be incurred prior to receiving the allowance
- (ii) Any expenses for out-patient medical/ dental treatment should be borne by the participants themselves

Regulations

Participants are required to comply with the following:

- (e) To return to their respective home countries/economies upon completion of the workshop, and

(f) To discontinue the workshop, in the event they fall seriously ill and are considered unable to continue the training or have committed an improper act
