**SUBJECT: MASTER OF PUBLIC ADMINISTRATION IN CHINESE GOVERNANCE FOR DEVELOPING COUNTRIES IN SUN YAT-SEN UNIVERSITY (SYSU) FROM SEPTEMBER, 2013 TO AUGUST, 2014 IN GUANGZHOU, GUANGDONG.**

The undersigned is directed to refer to Embassy of People Republic of China's Note Verbal bearing No. EA 02/13 dated 25<sup>th</sup> February, 2013 on the subject cited above.

2. Embassy of People's Republic of China has invited nominations of officials from the Government of Pakistan for the above mentioned Master training program.

3. The candidates have to meet the following criteria:

- 1) Government officials (BS-17 & above)
- 2) Minimum a bachelor degree in relevant field
- 3) Three years working experience
- 4) Younger than 45 years
- 5) In good health free from any infectious disease

4. The concerned Ministries /Departments are requested to furnish nominations of most suitable candidates fulfilling as per criteria by 8<sup>th</sup> April, 2013. The following documents must be submitted by the deadline. Documents received later than deadline will not be considered by the EAD:

- i) Nomination Form duly filled in by the nominee with office, residence and mobile phone number and fax numbers (two sets).
- ii) Undertaking form (two sets) from assisting official only.
- iii) NOC or undertaking by the nominating authority that once the nominated candidate will not be withdrawn after selection.
- vi) Medical certificate (Two copies)

\* On selection, the candidate has to provide undertaking and surety bond.

The expenses of the participants, including their tuition, fare for site visits organized by these side, fees for accommodation and setting, charge for medical insurance and fare for international travel, will be covered by the Chinese Government.
