The undersigned is directed to state that Government of People's Republic of China has offered various fully funded Multilateral/ Bilateral Seminar for Pakistan Government officials (list attached). Participant's qualification and requirements are as under:-

Eligibility Criteria

- Officers of Director General/ Director Level (BPS 17-20) from Ministries/Divisions Department most relevant to the training programme.
- Maximum age limit 50 years for DG Level and 45 years for Director Level.
- Be in good health and free from any infectious disease with health certificate.
- · Proficiency in English.
- NOC of the department concerned
- Passport having minimum validity of six months.

Expenses

The following expenses are to be borne by MOFCOM for the participants:

- Round-trip air tickets and transit allowance.
- · Boarding and lodging in China.
- Local transportation fees incurred for all activities arranged by the Chinese organizer.
- Pocket money of 60-80 Yuan RMB per head per day for officials and technicians respectively.

The following expenses are to be borne by the Participants themselves:

- Excessive luggage charges during international and domestic travels.
- Post and telecommunications, passport and visa issuance.
- Buy spectacles, see the dentist, or go to beauty saloon.
- Examination, diagnosis, treatment and medicine of any chronic disease.

- 2. All Ministries / Divisions and Provincial P & D Departments must note the following points while nominating the candidates:
 - a. Most relevant candidates should be nominated for the subject training course/seminar.
 - b. Nomination of candidates should reach EAD before the deadline. Late arrival of nomination after the EAD's deadline will not be considered.
 - c. The nomination papers complete in all respect should be forwarded to EAD through proper channel via their respective Administrative Ministry /Division/ P&D Department.
 - d. A candidate already availed foreign training within a period of less than one year, is not eligible.
- 3. It is requested that most suitable nominations alongwith required documents must reach to EAD as per the deadline mentioned against each course. Nominations received late or incomplete shall not be considered. All the information/forms/FTC proforma are available at www.ead.gov.pk
